1982 ASC MEETING CALL FOR PAPERS 33rd ANNUAL MEETING CALLED A SUCCESS

The 34th Annual Meeting of ASC will be held at the Sheraton Centre November 4-6, 1982, in Toronto, Ontario, Canada. HIGHLIGHTS OF ASC BOARD MEETINGS

November 14, 1981

Incoming President Harry E. Allen presided over his first Executive Board meeting on November 14th at the Capital Hilton Hotel in Washington, DC. He announced appointments (see story on page 4), all of which were approved by the Board.

Victoria Swigert, Holy Cross College, was appointed to fill the unexpired term of Marguerite Warren who had been elected Vice President-Elect.

Nominations Committee: Margaret Zahn, chair, presented a slate for 1982 elections, which were approved by the Board: Albert Reiss, Jr., Yale University, and Barbara Raffel Price, John Jay College of Criminal Justice, for President-Elect.

For Vice President-Elect, Austin Turk, University of Toronto; and Charles Wellford, University of Maryland.

For Executive Counselors (two to be elected), Ronald Huff, Ohio State University; James Inciardi, University of Delaware; Joan Petersilia, The Rand Corporation; and Gordon Waldo, Florida State University.

Election ballots will be mailed to the membership in March.

Finance Committee: Ronald Huff, chair, reported on the 1982-1983 proposed budget, amounting to \$81,550, which was approved by the Board. Issues concerning possible deficits were discussed. The committee also reported on the need for an audit and financial review, which were approved.

Archives Committee: Joseph E. Scott, Ronald Huff, and Dennis Longmire, all of Ohio State University, were empowered by the Board to negotiate with the library at that institution to establish an ASC archives. Their final recommendations are to be presented at the March Board meeting.

Student Affairs Committee: Frank Williams, Chair, reported on the feasibility of establishing student chapters of ASC. The Board approved the following recommendations: that ASC encourage the development of student groups with interest in criminology; that student groups look to the arrangement at the University of Florida as a model; and that local groups of students be listed in the forthcoming Membership Directory.

Interorganizational Committee: Clifton Bryant, Chair, reported that letters had been sent to numerous professional organizations that have concerns in the areas of criminology and criminal justice, requesting that an individual be identified to become part of a contact network. The committee will continue to work on other ideas to encourage of linkage of interested persons in the area of criminology.

Summaries of the November 10, 1981 Executive Board meeting and the Annual Business Meeting were not received in time for this issue. They will be published in the March 1982 issue of THE CRIMINOLOGIST.

Change of ASC Membership Year: Charles H. McCaghy, Treasurer, recommended and the Board approved changing the membership year to correspond with the Annual Meeting. Therefore, beginning in 1983, the membership year will begin on January 1st and end on December 31st.

LEGISLATION

Criminal Code Reform. The Senate Criminal Code Reform bill (S.1630) was approved by the Senate Judiciary Committee in late November. Condideration by the full Senate is expected in late January.

In the House, there are two criminal code reform bills under consideration, H.R. 1647 and H.R. 4711. Representative *Conyers'* Subcommittee on Criminal Justice has been holding hearings on both bills. The Subcommittee is expected to report out a House criminal code reform bill by the end of January.

Ball Reform. This Fall, hearings were held before Senator Hatch's Subcommittee on the Constitution on the issue of bail reform. The hearings concentrated on S. 1554 which would revise federal bail laws in numerous respects, the most controversial of which is a provision for pretrial detention. The Subcommittee approved S. 1554, with several amendments, in October. Action by the full Senate Judiciary Committee is expected in the near future.

In the House, Representative Kastenmeier's Subcommittee on Courts, Civil Liberties and the Administration of Justice has held two sets of hearings on revision of federal bail laws, focusing on the issue of pretrial detention. Several bail reform bills have been introduced in the House including H.R. 4362 which is substantially similar to S. 1554.

Death Penalty. S. 114, reported out by the Senate Judiciary Committee in July, would reinstate the death penalty for certain federal homicides, treason, and espionage, by providing constitutional procedures for its imposition. The full Senate is expected to vote on this bill in January, prior to consideration of the Criminal Code Reform Act.

Four bills to restore the death penalty at the federal level have been introduced in the House: H.R. 1534, H.R. 2283, H.R. 3541 and H.R. 3934 (apparently based on S. 114). There has been no action on any of these House bills to date.

Exclusionary Rule. Various proposals to eliminate or modify the exclusionary rule in the federal courts have been introduced. In October, the Senate Subcommittee on Criminal Law held hearings on S. 101 and S. 751, but the bills are still pending before the Subcommittee.

Firearms. Numerous bills representing the spectrum of views on gun control have been introduced in both the House and Senate. The most common feature of these bills is a provision for mandatory prison sentences for the use of a firearm in the commission of a felony.

Otherwise, the bills range from proposals for strict gun control to those to weaken the current provisions of the Gun Control Act. There has been no committee action on any of these bills although Senate hearings are expected in December.

Tax Disclosure Amendments. On November 16, the Reagan Administration submitted to the Congress a legislative proposal to facilitate federal law enforcement access to tax information for use in connection with nontax criminal investigations and prosecutions.

The Administration bill is similar in most respects to S. 732 (discussed in previous editions) and has been introduced in the Senate as S. 1891 by Senators Roth, Nunn, Rudman, and Chiles. A Subcommittee of the Senate Finance Committee held hearings on the issue of tax disclosure on November 9 and a Subcommittee of the House Ways and Means Committee is expected to hold hearings on the issue in December.

Federal law enforcement officials contend that amendments to existing disclosure laws are urgently needed to strengthen law enforcement efforts against narcotics traffickers, organized crime syndicates, and other offenders whose crimes involve large sums of money. Tax information is often an important source of evidence in such sophisticated crime cases.

Posse Comitatus Amendments. On November 17, the House approved the Conference Report on the Department of Defense authorization bill, S. 815, clearing the bill for action by the White House.

Sec. 905 of S. 815 would improve cooperation between military authorities and civilian law enforcement officials, particularly in connection with monitoring air and sea traffic involved in smuggling narcotics, customs contraband, and illegal aliens into the United States.

The Posse Comitatus Act (18 U.S.C. 1385) has long impeded cooperation between civilian and military officials in such matters and this new law, by facilitating appropriate cooperation, will enhance law enforcement efforts.
