"The 1982 Annual Meeting in Toronto will have a full and varied program," announced *Israel Barak-Glantz*, Program Chair. "Members of the Society have been making excellent suggestions for the program," he added.

The 34th Annual Meeting will be held at the Sheraton Centre, November 4-6, 1982. It is expected that winners of the various annual awards will be invited to address the membership at plenary sessions. In Memoriam

Frederick Alan Hussey, age 38, died January 11, 1982. Associate Professor, Administration of Justice, Pennsylvania State University. Member of the graduate faculty and was coordinator of field experiences in the administration of justice curriculum. Taught undergraduate and graduate courses including probation and parole, research methods, values and goals. Graduate of University of Maine; received doctorate from Brandeis Univ. Survived by wife, Sandra, daughters, Jennifer and Andrea, son, Kevin and stepson, Daniel (242 Academy St., Boalsburg, PA). The author of numerous articles, Dr. Hussey was co-author of *Probation, Parole and Community Field Service: Policy Structure and Process*.

Leonard J. Hippchen, died January 21, 1982. A long time member of ASC, he was Professor, Department of Administration of Justice and Public Safety, Virginia Commonwealth University. Member of the graduate faculty; chairman, department graduate committee. Graduate, Univ. of Texas/Austin; PhD, State Univ. of Iowa. Fellow of the ASA. Selected as special delegate to the 5th & 6th UN International Conference on the control and prevention of crime and delinquency. Author of numerous publications and listed in several registers of professional persons. Survived by wife June and 3 children (1701 Crumpets Court, Richmond, VA 23235).

BAUNACH RECEIVES AWARD

The Educational Foundation of the American Association of University Women (AAUW) has selected *Phyllis Jo Baunach* as the recipient of the 1982 Recognition Award for Young Scholars. This is an award established in 1972 to identify and encourage a woman under the age of 35, who by early accomplishment in her discipline, gives promise of future distinction.

The Recognition Award is an integral part of both the AAUW and the AAUW Educational Foundation programs, as it recognizes women who serve as role models and provide encouragement to aspiring women professionals.

Baunach, a correctional research specialist with the National Institute of Justice, and an Executive Counselor on the ASC Board, completed research on women inmates who are mothers and the effect of their separation on both them and their children. Her research has led to the drafting of legislation in various states to form programs for these women.

She will receive her award in June, 1982 at the AAUW State President's Conference in Washington, DC.

HIGHLIGHTS OF ASC BOARD MEETINGS**November 10, 1981**

Membership Committee: President *Frank Scarpitti* reported that Sage Publications had mailed 40,000 brochures inviting membership into the Society and that it is expected that additional brochures will be mailed in the future. *Chris Eskridge* and *Dennis Longmire*, Co-Chairs, were instructed to develop a membership drive, contact previous members to determine the reasons for having dropped membership, and to locate missing former members.

Joint Commission on Criminology and Criminal Justice Education and Standards: President-Elect *Harry Allen* reported that the Commission has published 10 monographs and has drafted a final report, which will be called *Quest for Quality*. A conference held in Chicago recently to discuss the findings of the Commission was well attended. Details about availability of the publication will be announced.

Division on International Criminology: The Board gave its final approval for the establishment of the Division as a permanent entity within ASC. The group, headed by *Elmer Johnson*, will be asked to cooperate with the Program Chair of forthcoming Annual Meetings in developing panels.

Constitution and By-Laws Committee: *Barbara Raffel Price*, Chair, reported that the committee discussed a proposal to eliminate the offices of Vice-President-Elect, and President-Elect and develop a system of electing two Vice-Presidents, who would succeed to the presidency. The committee rejected the proposal, the decision of which was affirmed by the Board.

Site Selection Committee: *Harry Allen* reported that the committee was recommending Baltimore as the site of the 1986 Annual Meeting, which was affirmed by the Board. *Edward Latessa*, Chair, was instructed to make recommendations to the Board for the site of the 1987 meeting.

National Association of Probation and Parole: *Frank Scarpitti* reported that a request had been received from APPA to endorse a John Augustus Award, to celebrate the bicentennial of the founder of probation in the United States. The Board voted to offer such an endorsement.

ASC Resource Personnel: *Joseph Scott* reported that ASC had received a letter from a university requesting suggestions for persons to serve as reviewers of a department. *Alvin Cohn* was asked to survey national organizations on how they address such requests and report to the Board for the March meeting.

Amicus Brief: A request had been received from *Matthew Yeager* to help him in his court case against the Drug Enforcement Administration. He is seeking certain documents under the Freedom of Information Act. Specifically, ASC was asked to join other organizations in filing an Amicus Brief. The Board voted to commission the Brief and to ask selected members of the Executive Board to serve as consultants to the drafter of the Brief.

Consortium of Social Sciences Association (COSA): The Board received a request that it pay \$1.00 per year per member to support COSA's lobbying efforts in the area of legislation affecting social science. The Board voted to decline affiliation or to make a financial contribution.

CALLS FOR PAPERS**ASC Gene Carte Student Paper Competition**

Full-time students in the fields of criminology and criminal justice are invited to submit papers in this annual competition. Papers may be of a theoretical or empirical nature, 6,000 words or less, must be typed, double-spaced, appropriately footnoted, and submitted in triplicate.

Cash awards of \$300, \$150, and \$100 will be given to the three best papers, the writers of which will be invited to participate in the 1982 Annual Meeting, to be held in Toronto.

The deadline for submissions is April 15, 1982 and should be sent to *Theodore Ferdinand*, College of Criminal Justice, Northeastern University, Boston, MA 02115.

Others on the judging committee are *Brent Smith*, University of Alabama, and *Sue Titus Reid*, University of Oklahoma.

Criminal Justice Review

The *Criminal Justice Review*, a multidisciplinary, refereed journal, which is published semi-annually, will consider for publication manuscripts which treat topics of interest to criminal justice scholars and practitioners.

Papers are being solicited in the areas of crime and the elderly, the future of the federal role in criminal justice, sentencing reform and its implications, applications of anthropology to criminal justice, the impact of modern court administration upon criminal case processing, and the judicial role in the administration of criminal corrections.

LEGISLATION

Program Fraud Civil Penalties. There has long been concern over the inability of the Department of Justice to prosecute, either criminally or civilly, every instance of fraud against the government uncovered by the various federal departments and agencies. The situation is such that small fraud cases are seldom prosecuted unless they involve bribery or corruption on the part of a federal official.

To establish an administrative alternative to judicial proceedings in such small fraud cases, Senator *Roth*, joined by Senators *Rudman*, *Cohen*, and *Nunn*, has introduced S. 1780 to authorize agencies to initiate administrative hearings which can result in the levying of civil money penalties together with assessments of up to double the amount of the claim or the amount of the government loss as an alternative to judicial proceedings.

The *Roth* bill is similar to a proposal being developed within the Reagan Administration to deter fraud against the government and to recover federal funds now being lost as the result of false claims. The Senate Governmental Affairs Committee is expected to hold hearings in March on this proposed administrative alternative to judicial proceedings.

Armor-Piercing Handgun Ammunition. Although the frequency of armed assaults on law enforcement officers remained relatively constant from 1975 to 1980, the number of resulting police deaths dropped by about 20 percent due in large part to increased use of soft body armor.

Recent publicity surrounding the "KTW" bullet, which can penetrate multiple layers of bullet-resistant body armor, will likely produce a flurry of legislative activity aimed at protecting law enforcement officials from this threat. Already in the legislative hopper is H.R. 2280, introduced by Rep. *Biaggi* of New York, to authorize a study of handgun ammunition capable of piercing bullet-resistant apparel.

Bank Secrecy Act Amendments. The Bank Secrecy Act of 1970 requires reporting of certain cash and foreign currency transactions as a means of preventing "money laundering" and related schemes associated with narcotics trafficking and organized crime. Federal law enforcement officials maintain, however, that amendments to the 1970 law are needed.

In an effort to strengthen enforcement of the law, Senator *Roth*, joined by Senators *Rudman*, *Cohen*, *Nunn*, and *Chiles*, has introduced S. 1907, which would increase the sanctions for violations of currency transaction reporting requirements; create a new attempt provision; authorize payment of rewards to persons providing information leading to recovery of a criminal fine, penalty, or forfeiture; and authorizing searches by customs officials of persons leaving the country if there is reasonable cause to believe that they are illegally transporting unreported currency. This legislation is pending before the Senate Judiciary Committee.

Use of Herbicides for Marijuana Eradication. In 1978, the Congress established restrictions upon US assistance to foreign nations in support of marijuana eradication programs involving the use of herbicides. The Attorney General's Task Force on Violent Crime recommend repeal of these restrictions as a means of strengthening the national effort to control drug trafficking.

The Congress, due to increased concern over the national drug problem, has now rescinded the 1978 restrictions by virtue of Sec. 502 of Public Law 97-113. As a result, there will be renewed efforts to encourage drug-exporting nations to undertake marijuana eradication programs through aerial application of herbicides such as paraquat.

Criminal Forfeiture. Bills have been introduced in both the House and Senate to expand the authority of the government, in drug trafficking and racketeering cases, to obtain the forfeiture of illegal profits and other assets used in the commission of these crimes.

Heightened congressional concern about the tremendous influx of drug monies, particularly in the southeastern States, is clearly the primary impetus for current interest in this subject. This fall, in testimony before both the House and Senate Judiciary Committees, the Attorney General included criminal forfeiture among the areas to be addressed in the Administration's legislative program for combatting crime.

Rep. *Hughes* has already held one hearing on this subject, and his Subcommittee on Crime is expected to hold another in February at which the Department of Justice will likely unveil its comprehensive forfeiture legislation.

In the Senate, Sen. *Biden*, ranking minority member of the Judiciary Committee, appears to have an interest in this area, as does Sen. *Dole*.

Labor Racketeering. Ten Senators, including Senators *Nunn* and *Hatch*, have joined as sponsors of S. 1785 (an earlier version of this bill was S. 1163), which is designed to ease the removal of convicted felons and racketeers from union and employee benefit plan office. Much of the groundwork for this bill was laid in the continuing hearings on labor racketeering held by the Senate Permanent Subcommittee on Investigations.

As of this writing, the Subcommittee on Labor had scheduled hearings on S. 1785 for the last week of January. The AFL-CIO has come out in support of all but some minor aspects of the bill, and with this backing chances for favorable congressional action seem good.

Update on Bills Discussed in Previous Issues. The Senate Judiciary Committee has issued its report on the Criminal Code Reform Act, S. Rep. No. 97-307; action by the full Senate on the bill is expected in February. The Judiciary Committee has also approved comprehensive bail reform legislation, S. 1554, the provisions of which were largely incorporated in the criminal code bill as well.

The House Ways and Means Committee held hearings on proposed tax disclosure amendments on Dec. 14, 1981. Posse Comitatus amendments to authorize increased military support for civil law enforcement efforts have been enacted as Sec. 905 of Public Law 97-86.

REPORT OF ASC 1981 ANNUAL BUSINESS MEETING

The Annual Business Meeting of ASC was held November 12, 1981 in Washington, DC. *Frank Scarpitti*, President, presided.

Charles McCahy, Treasurer, reported that the Society was solvent and had approximately \$52,000 on hand. He also reported that ASC had purchased a word processor and was now capable of preparing more materials at less cost.

Frank Scarpitti reported for the journal, *CRIMINOLOGY*, and that 218 papers had been submitted in the preceding 12 months, of which 25 had been accepted for publication. The time lag between receipt of papers and publication decisions was less than 80 days.

Mike Gottfredson reported on the Research Progress Series, published by Sage. Five new volumes, including papers from the 1980 Annual Meeting, have just been published. Papers to be included in the 1981 series will be determined by February, 1982.

It was announced that ASC had granted official status to the Division of International and Comparative Criminology and that consideration was being given by the Board for the creation of a Division on Women and Crime.

Other reports presented at the meeting covered such topics as the 1981 and 1982 Annual Meetings, results of elections, and the status of the Joint Commission on Criminology and Criminal Justice Education and Standards.

POLICE MANAGEMENT ASSOCIATION ESTABLISHED

The Police Management Association (PMA), an independent non-profit membership organization incorporated in 1980, seeks members who are interested in exchanging information, fostering research, and taking a stand on issues critical to policing.

PMA's current membership includes more than 125 police middle managers, police researchers, police legal advisors, and full-time criminal justice academicians from the United States, Canada, and Great Britain. Chiefs of police from jurisdictions having fewer than 200 officers or a population of less than 100,000 are also eligible for PMA membership.

PMA hopes to fill a void by serving as a forum through which police middle managers and others eligible for membership can improve the delivery of on the street police services and the quality of police management.
