RECORD ATTENDANCE EXPECTED FOR 1982 ANNUAL MEETING

Approximately 800 persons are expected to be on the program of the 34th Annual Meeting of ASC. Six plenary sessions, an annual Business Meeting, several social events, 133 Panels, and 31 Roundtables will fill the program for the more than 1,000 participants expected to attend.

With the theme of "Crime and Criminology in the Americas," *Israel Barak-Glantz*, Program Chair, and *Harry Allen*, ASC President, have planned a complete program, which will be held at the Sheraton Centre, November 4-6, 1982, in Toronto, Canada.

the Vollmer Award, and *Frederick McClintock*, winner of the Sellin-Glueck Award, will each present major addresses at plenary sessions.

The three other plenaries are being organized by *Albert Reiss, Jr.*, *Marvin Zalman*, and *Marvin Wolfgang* on subjects of critical importance to the field of criminology.

International Criminology and Women and Crime divisions of ASC will co-sponsor a no-host cocktail party on Wednesday evening. John Jay College of Criminal Justice will host a social on Thursday evening. The annual banquet, preceded by a no-host cocktail party is scheduled for Friday evening. As of press time, the major speaker for the banquet had not been announced.

Harve Horowitz continues to serve as ASC's Advertising and Exhibits Representative. He has indicated that the Toronto exhibit will be as complete as those in prior years and may even surpass them. As has become a tradition, ASC members are encouraged to notify *Horowitz* of recent publications so that arrangements can be completed to exhibit such books at the ASC Combined Book Exhibit.

The Executive Board is scheduled to meet on Wednesday afternoon, November 3rd, from 1:00 to 5:00 p.m. This will be the last meeting over which *Allen* will preside. On Saturday, November 6th, *Travis Hirschi* will preside over the first Board meeting for his administration. This meeting is scheduled for 7:30 to 11:00 p.m.

The Annual Business Meeting is set for Friday, November 5th, at the Sheraton Centre, from 3:30 to 4:30 p.m. All committee chairs are expected to present reports of deliberations and activities to the membership at that time.

The Preliminary Program (printed in this issue of *THE CRIMINOLOGIST*) and materials concerned with program and hotel registration are being mailed to the membership. Those expecting to attend are reminded that the hotel costs are indicated in Canadian dollars, which are approximately 15 percent higher than American dollars. Participants should send their registration forms in as early as possible.

The Professional Employment Exchange will be another feature of the Annual Meeting. Persons and institutions wishing to register for the Exchange should send for appropriate forms and submit them to the Executive Offices of ASC in Columbus no later than three weeks prior to the meeting.

GORDON TULLOCK RECEIVES WILKINS BOOK AWARD

The School of Criminal Justice of the State University of New York and the Michael J. Hindelang Criminal Justice Research Center, Inc. of Albany, New York, recently conferred the first Leslie T. Wilkins Award for the best book-length work in the field of criminology and criminal justice.

The work selected for this honor by the Awards Committee is *Trials on Trial: The Pure Theory of Legal Procedure*, by Gordon Tullock of Virginia Polytechnic Institute and State University. The award carries an honorarium of \$500.

The citation honors Tullock for having "challenged the imagination and expanding the horizons with a new, fresh, and innovative approach to questions facing our justice system," and for his "lucid exposition of a complex econometric model which is intriguing and a joy to read."

Trials on Trial offers an approach to legal procedure which, among other things, explores ways of enhancing the impact of law by attending to the validity and cost of legal decisions.

The committee is now accepting nominations for next year's award. Nominations can be made by publishers, authors, and others in the field. BURKHART HEADS NIJ

Attorney General William French Smith has named Walter R. Burkhardt acting director of the National Institute of Justice, a criminal justice research arm of the Department of Justice.

Burkhart succeeds James L. Underwood, who resigned recently to return to the University of South Carolina to teach law.

Burkhart joined the institute in 1970 as a social scientist. His most recent position was director of the Office of Research Programs.

From 1968 to 1970, Burkhardt was a National Institute of Mental Health Research Fellow at the University of London. Prior to that he worked for 10 years with the California Department of Corrections as a parole officer, research supervisor, regional parole supervisor, regional parole administrator, and administrator for planning and evaluation.

JEREMIAH PATRICK SHALLOO

1898-1982

Requiescat In Pace

Jeremiah Patrick Shalloo, emeritus professor of sociology, University of Pennsylvania, passed away on May 22nd in Concord Hospital, Concord, New Hampshire.

Jerry was my first professor of criminology and later criminological inquisitor at my doctoral orals – and for over 40 years my friend. He was an outstanding teacher: charming yet cynical, dedicated but humorously down-to-earth, witty, and profound. He was enthusiastic, almost hyper-kinetic, intimidatingly convincing – imbuing all of his students with his passion and his zeal.

Jerry had strong opinions and even stronger likes and dislikes – and I am afraid he at times did not hesitate to propagandize – fortunately, however, his views and mine coincided.

Originally trained in English and History at Clark University, he took his PhD in Sociology at Pennsylvania where with Thorsten Sellin he pioneered the criminology curriculum now headed by Marvin Wolfgang.

He was a stalwart of the American Correctional Association, always the center of a jolly beer-drinking cabal at the Annual Congress of Corrections, executive editor of the American Journal of Corrections (and in the opinion of many wrote not a few of the Cocklebur columns which most irreverently took the hide off phoney corrections administrators and equally phoney correctional programs).

Jerry received many professional recognitions: the Edward R. Cass Award of ACA, the Ivy Club Lecturer Award of the University of Pennsylvania, the Page I Award of the Newspaper Guild, and an award from the Fraternal Order of Police.

Jerry is survived by Bernece, his wife of over 50 years, who can be addressed at Main and Depot Streets, Warner, New Hampshire.

Jerry's family, the Shalloos, come from the village of Ennistymon, in the County of Clare (and mine from the village of Lahinch just two miles westward toward the sea). It is fitting then that his epitaph be in Irish: AR DHEIS DE GO RAIBH A ANAM DILIS. NI BHEIDH A LEITHEID ARIS ANN. May his soul be on the right hand of God. We will not see his like again.

DEPARTMENTAL NEWS AND NOTES

Univ. of Maryland: The Institute of Criminal Justice and Criminology has added five new faculty, all of who will be teaching full-time beginning Fall, 1982, announced *Charles Wellford*, Director.
