DENVER TO HOST ASC's 35th ANNUAL MEETING

Preparation for the ASC's 35th Annual Meeting is progressing rapidly, according to *Joseph E. Scott*, Program Chair. The meeting will be held November 9-13, 1983, at the Denver Marriott Hotel-City Center. The Denver Marriott has quoted the ASC rates of \$44.00 for singles and \$54.00 for doubles per night. *Scott* reports that "the Marriott has agreed to credit the ASC's master account \$2.00 per night for every room occupied by participants to defray the cost of the banquet."

The Causes and Consequences of Crime: Multidisciplinary Contributions has been adopted as the theme of the Meeting. By examining multidisciplinary contributions, the theme emphasizes an assessment of the state of criminology by focusing upon the causes and consequences of crime and the legacy of the discipline.

In addition to papers addressing the theme of the meeting, the Program Committee is also soliciting presentations on a broad range of topics. Members, as well as non-members, are invited to suggest specific panel topics as well as alternative modes of presentation.

Papers, abstracts or proposals for a panel, symposium, plenary, workshop or didactic session must be typed double-spaced, and submitted in triplicate to the appropriate Program Committee member prior to April 1, 1983. Each submission should include on the title page not only the author(s) and affiliation(s), but also complete address(es) and phone number(s). If the content is judged more suitable to another area, it will be forwarded to the appropriate committee member.

1982 ANNUAL MEETING ATTRACTS LARGE ATTENDANCE

Seven hundred twenty-six registrants attended the 34th Annual Meeting of ASC. With the theme "Crime and Criminology in the Americas," *Israel Barak-Glantz*, Program Chair, and *Harry E. Allen*, ASC outgoing President, report that the meetings at the Sheraton Centre, November 4-6, in Toronto, Canada, was an international success. Registrants from not only across all of North America, but England, Australia, Germany, Israel, Finland, The Netherlands, and Kuwait attended the meetings. The program included 134 sessions, 6 plenary sessions and 31 roundtables.

A new innovation for this year's meeting program was the publication of abstracts of the papers presented. This innovation was very well received by the attendees and numerous, positive responses were expressed to this new idea. The Society is exploring the possibility of continuing publication of meeting abstracts in the future. Minutes of the Executive Board and Annual Business meeting will be published in the March newsletter.

CALL FOR ENTRIES

1983 ASC GENE CARTE STUDENT PAPER COMPETITION

The ASC is soliciting papers from full-time students currently enrolled either in the graduate or undergraduate level for the ASC Gene Carte Student Paper Competition.

All entries must be empirical and/or theoretical papers related to criminology. Papers must be 6,000 words or less, typewritten, double-spaced on 8½ x 11 white paper using standard format. Since papers will be evaluated anonymously, author(s) name(s) and affiliation(s) should appear only on the title page.

Three copies of the paper should be submitted on or before April 15, 1983, to: Professor Dean G. Rojek, Department of Sociology, Baldwin Hall, University of Georgia, Athens, GA 30602.

Criteria for evaluation of the papers will include significance of the topic, quality of theoretical orientation, methodology, scholarly comprehensiveness and interpretation, quality of writing, and contribution to the field. The author of entries selected by the judges for awards will be notified in writing by August 1, 1983.

The 1st, 2nd, and 3rd place papers will be awarded monetary prizes of \$300, \$150, and \$100, respectively, and will be eligible for presentation at the 1983 meeting of The American Society of Criminology in Denver, Colorado, November 9-13. Prize-winning student papers will be integrated with the general sessions of the Society's meeting, according to substantive content. Students also will be acknowledged at the Annual Meeting Awards Ceremony.
