HERBERT BLOCH AWARD TO JOSEPH E. SCOTT

Joseph E. Scott, Program Chair of the 1983 Annual Meeting, has been named the 1983 winner of the Herbert Bloch award for his outstanding service to the Society and the profession.

The award reflects Scott's extensive contributions to the Society including membership on the Executive Board (1974-1981), Editor of THE CRIMINOLOGIST (1975-1978), Executive Secretary (1975-1981), Chair of the Ethics Committee (1978-1980), and Chair of the Finance Committee (1978-79).

In addition to his extensive contributions to the Society, Scott has a long

record of community service, and professional publications.

He is currently an Associate Professor at The Ohio State University, and

Director of the Criminology and Criminal Justice Major.

Since 1976 the Herbert Bloch winners have been: Harry E. Allen (1977); Barbara Raffel Price (1978); William E. Amos and Edward Sagarin, (1979); Alvin W. Cohn (1980); and James Inciardi (1982).

GIBBS RECOGNIZED WITH SUTHERLAND AWARD

Jack Gibb's contributions to theory and research have been recognized by awarding him the 1983 Edwin H. Sutherland Award. The Sutherland Award recognizes Gibb's outstanding contributions to both theory and research in criminology. His research and theoretical contributions to the field date from 1953 when he published "Law and the Mores" with Austin Porterfield in Sociology and Social Research. Since that publication he has consistently made significant contributions to the field.

Gibb is currently Centennial Professor of Sociology at Vanderbilt Univer-

sity and a fellow of the American Society of Criminology.

The previous five winners are: Seymour Halleck (1978); James Short (1979); Gresham Sykes (1980); Albert Reiss, Jr. (1981); and Gwynn Nettler (1982).

SELLIN-GLUECK AWARD TO ANTTILA

Inkeri Anttila of Finland has been awarded the Sellin-Glueck Award In recognition of international contributions to criminology. Anttila, currently Director of the Helsinki Institute for Crime Prevention and Control, has been Professor of Criminal Law, University of Helsinki (1961-1979), and Minister of Justice and member of Cabinet (1975).

From 1965 through 1980 Anttila was vice-president of the International Penal and Penitentiary Foundation and is currently on the Board of Directors of the International Association of Penal Law, Vice-President of International Society for Criminology, Chairman of the Board of International Center of Comparative Criminology, and Vice-President of the International Society of Social Defense.

In addition to these activities, Inkeri Anttila has published 11 books and almost 120 articles on criminal law, criminology and the criminal justice system.

The last five previous winners of the Sellin-Glueck award were: Nils Christie (1978), Norway; Johannes Andenaes (1979), Norway; Hans Jescheck (1980), Federal Republic of Germany; William Nagel (1981), Netherlands; and Frederick McClintock (1982), Scotland.

BJS REPORT SHOWS VICTIMIZATION DECLINE

Al Paez and Fred Shenk of the Bureau of Justice Statistics report that criminal victimization declined during 1982. In their September report entitled, "Criminal Victimization in the United States" they indicate almost 1.7 million fewer victimizations occurred in 1982 than in 1981.


Figure 1 reports victimization trends from 1973 through 1982 for specific categories of crimes. Figure 1 indicates that although crimes of violence as a group—rapes, robberies, and assaults—did not significantly decline there were significant declines in burglary and larcenies.

Residential burglary accounted for the largest share of the decline in the

National Crime Survey. According to the Survey there were 731,000 fewer burglaries in 1982 than in 1981. This represented 43 percent of the entire decline in victimization.

The authors point out that the victimization rates have been relatively stable since the program began and that these changes between 1981 represent "one of the most sweeping, single-direction changes to have taken place since the program's inception."
