MEMBERSHIP COMMITTEE REPORTS ON ACTIVE YEAR

Chris Eskridge, chair of the Society's Membership Committee, reports that the Committee has completed an active and productive year. Eskridge reported that 238 new members were recruited during the first ten months of 1983. Of these, 140 are active members and 98 student members.

Membership in the Society currently stands at 1749 members in good standing which is a 4.4 percent increase over last year at this time. In fact, Eskridge pointed out, "We presently have more active members than at the end of last year."

The Committee concluded that "the membership figures are very solid." However, the Committee does have reason for concern. Despite the increase in membership over last year, Eskridge cautioned that the past year was marked by a reduction in the number of new members recruited.

He reports that: "This year we will probably have the smallest number of new members than in the past ten years." To balance out this decline the Society was able to retain a larger portion of our present active members than any of the previous five years.

The Committee intends to continue its efforts to retain and recruit. Current members are encouraged to assist the Committee's efforts by encouraging colleagues to join the Society.

Besides Eskridge, the Committee includes *Kevin Wright*, *Karen Gilbert* and *Roy Roberg*.

In Memoriam

Catherine M. Hartnett
1927-1983

The Society is saddened at the death of Catherine M. Hartnett on October 23, 1983. Catherine, who was 56, was an active member in the Society. In 1982 she served on the Site Committee and in 1983 she served on the Recruitment Committee.

Born in Wilmerding, Pennsylvania, the second youngest of eight children, she received college degrees in business administration, history and sociology from Ohio Dominican College (B.S.), Duquesne University (M.A.), Illinois Institute of Technology (M.S.), and Ohio State University (Ph.D.).

She became an assistant professor of sociology at Albany State College in 1970. In 1980 she was selected chairperson of the Department of Criminal Justice and in 1982 she became the Director of the Criminal Justice Institute.

She received numerous awards including Outstanding Educator of America (1974) and a Fulbright Travel-Study Scholarship (1974).

Dedicated to community service, she served on the boards of directors for the League of Women Voters, the Liberty House and the Fraternal Organization of Police Associates. Additionally she was a member of the Community Relations Council, Turner Job Corps and the chairperson of the Legislative Committee of the National Conference of Catholic Women.

In paying tribute to Catherine a close colleague describes her as follows:

"It was a privilege to have known and worked with Catherine M. Hartnett. She was a dynamic person. Her energy and enthusiasm affected all of us who were around her. While she was a highly motivated person with great administrative skill, she did not neglect the human side of her relationships. She was devoted to both students and faculty. She took a personal interest in the problems of others, both personal and school related. In fact, one of the dominant characteristics of her personality was her desire to serve others. She was active in her church and a member of many community organizations, especially those dedicated to helping others. She willingly participated in many student and college activities. Catherine was loved by all who knew her, and each of us are better for having known her. She will be missed by her many friends and especially those of us at Albany State College."

JUSTICE ANNOUNCES JUVENILE PROGRAMS

Three programs directed at juvenile gangs and at the chronic, serious juvenile offender were announced by *Alfred S. Regnery*, Administrator, Office of Juvenile Justice and Delinquency Prevention (OJJDP).

Two of the programs, totalling nearly \$5 million, will operate in up to a dozen cities over a two-year period.

The programs will focus on the very small percentage of the juvenile population—five to eight percent—that research indicates accounts for over 50 percent of juvenile crime. Regnery noted: "What we will be doing is putting this knowledge into practical implementation. By prosecuting the relatively few juveniles who are committing the majority of the crime—sometimes 100 to 200 offenses per kid—we should be able to make a substantial reduction in juvenile crime."

One award of \$324,845 has been made to the Rand Corporation, Santa Monica, California, for a one-year project to research and develop intervention strategies for chronic, serious juvenile offenders.

Another program, "Operation Hardcore," will attack the juvenile gang problem by awarding grants of up to \$400,000 each to five cities to expedite the preparation and presentment of serious and violent gang-related cases involving robbery, first degree burglary, forcible sexual offenses, aggravated assault, repeated killings, and intimidation of witnesses.

As part of "Operation Hardcore," a victim/witness protection and relocation unit will be developed by the grantee. Also, a corrections component will be implemented. The two-year grant awards will be made to prosecutors' offices on a competitive basis.

In announcing the grants, Regnery said, "Data suggests that gang violence in some parts of the United States constitutes a major crime problem. According to a 1981 nationwide survey, youth gangs and law-violating groups are a major problem to many police departments."

Under the third grant, prosecutors in six cities will receive up to \$600,000 each for two-year programs aimed at the "Habitual Serious and Violent Juvenile Offender." These projects, to be awarded under competitive bidding, will be directed at preparing and presenting to the courts, in an accelerated manner, the cases of violent and serious juvenile offenders who frequently commit robbery, forcible sex offenses, or first degree burglaries and are involved in more than one homicide.

Regnery said habitual offender programs would be aimed at concentrating on these repeat serious offenders by reducing the delays brought about by pre-trial hearings, deposition and trial delays; restricting or eliminating plea bargaining; reducing the number of dismissals for reasons other than merit; ensuring that all evidence is collected in an admissible

manner; improving methods for obtaining cooperation of victims and witnesses; and assigning one prosecutor to the same case from the time of arrest through final disposition.

Regnery said that gang control and the habitual offender programs for juveniles are designed, by and large, after career criminal projects that have proven successful in prosecution of adult offenders. He said the Rand study was intended to discover other effective strategies for reducing hard-core juvenile delinquency.

The purpose of Operation Hardcore is based on previous research which has found that there are a minimum of 760 gangs and 28,500 gang members in just the six cities that have reported serious gang problems — New York, Chicago, Los Angeles, Philadelphia, Detroit, and San Francisco.

Regnery said "Operation Hardcore" is an approach to juvenile gang control through selective and targeted prosecution. He said gang-related felony cases will be handled in a priority manner. One prosecutor will be assigned to gang member cases throughout the entire judicial process. There will be reduced prosecutor caseloads to allow the prosecutor to focus more on an individual case. Specialized resources will be made available for witness assistance, protection and relocation.

Goals of the program will be:

- Speedy prosecution of juvenile gang members who are committing repeated and serious or violent gang-related delinquent acts.
- Reducing incidents where gangs intimidate witnesses who are to testify against them in court.
- Prevention of gang crime by isolating and prosecuting the most serious gang offenders.
- Increased cooperation among police, prosecutors, neighborhood groups, probation officials, schools, and youth organizations.

These problems, which will be very similar to the habitual offender projects, also will seek to reduce trial delay, reduce or eliminate plea bargaining, and reduce dismissals for reasons other than the actual merit of the cases.

The deadline for cities to apply for the "Operation Hardcore" projects is November 30, 1983. The application deadline for the "Habitual Serious and Violent Juvenile Offender Program" is December 19, 1983.

SENTENCING RESEARCH VOLUMES PUBLISHED

Two volumes of *Research on Sentencing* have been published by the National Academy Press.

The study is a resource for everyone concerned with the design, implementation, and evaluation of sentencing reforms. It was conducted for the National Institute of Justice of the Department of Justice by a panel chaired by Alfred Blumstein of the School of Urban and Public Affairs at Carnegie-Mellon University.
