Announcing a New ASC Monographs Series

The American Society of Criminology will continue, as it has in the past, to sponsor the publication of criminological works. We recognize that, as a scholarly society, we have an obligation to facilitate and to promote the publication of scholarly work, not only through our journal but also, where appropriate, through books. The first and overriding criterion for deciding what to publish is the value of the proposed publication to the profession. The limited resources and the imprimatur of the Society must be reserved for books that respond to current need, especially need that is not otherwise likely to be met, or to be met in timely fashion. Such books might be actively solicited by the Society or they may be submitted or proposed by members. They may deal with policy issues, criminological theory, research or methods. They may be monographs by a single author or collection by many authors. Our second main criterion is that these be works of high quality, which means that they will be carefully selected, reviewed, and edited. We intend for them to constitute a truly distinguished series. Marketability and similar considerations, although rele-

ANNUAL MEETING

NOVEMBER 13-17, 1985

PRELIMINARY PROGRAM

THE annual program of the American Society of Criminology will be held at the Town and Country Hotel in San Diego, California from Wednesday, November 13, through Sunday, November 17, 1985. The meeting will begin at 3:00 with opening addresses by James K. Stewart and Steven R. Schlesinger. Mr. Stewart holds the title of Administrator, National Institute of Justice while Dr. Schlesinger is Director of the Bureau of Justice Statistics.

The theme for the meeting this year is "Taking Stock: Current Knowledge and Future Priorities." A Keynote Plenary Session is scheduled for Thursday, November 14, to focus on the theme. The Keynote Plenary Session, "Criminology: Projections and Priorities" will feature as speakers: Alfred Blumstein, Gerhard O. W. Mueller, Austin T. Turk, and Marvin E. Wolfgang.

In addition to the Keynote Plenary Session, Stanley Cohen, the winner of the Sellin-Glueck Award, will present a Plenary Session. A future issue of *The Criminologist* will provide more information on these sessions.

The Local Arrangements Committee has planned a variety of professional, cultural and social activities for the 1985 meetings. Included are tours of San Diego cor-

rectional facilities; a tour of a correctional facility in Tijuana, Mexico, is in the planning stages. Social and cultural events include a planned dinner at Sea World; a tour of San Diego harbor on a sailing ship; a dinner cruise on the Showboat, an authentic stern-wheeler; and several shopping tours.

In addition, for your recreational enjoyment, the Town and Country Hotel makes available, for a nominal fee, the facilities of the Atlas Health Club. The Atlas Health Club offers facilities for Tennis, Handball and Racquetball. Lap pools, exercise rooms for men and women, a sauna and therapy pool, and running guides are also available.

Workshop to Develop Skills In Using Large Data Sets

A workshop at the Louisiana State University on Analytical Techniques and the Use of Large Data Bases in Criminal Justice will be held October 7-9, 1985. The workshop will be an intensive hands-on experience for criminal justice researchers and practitioners emphasizing analytical methods, large data bases and archival data, and the use of personal computers for data base management and statistical analyses, etc. Software sharing and literature exchanges will be facilitated.

Included in the workshop will be research techniques such as sampling, data collection, storage and documentation, data base management and analysis. Data bases such as UCR, NCS and Prison and Jail Censuses and Surveys will be used as examples of the issues and problems in handling large data sets. In addition, the workshop will focus on the possible limitations and misuses of large data bases, data issues in prediction and longitudinal research techniques. The experts will be available to share their knowledge and expertise with participants.

All workshop materials, breaks, an evening banquet and a barbeque are included in the \$225 registration fee (\$275 late fee after August 1. Enrollment is limited, acceptance is on a first come, first serve basis.
