From Risk to Wellness: Strategies in School Violence Prevention Interventions

The recent occurrence of several highly publicized school shootings, such as the one at Columbine High School, has stimulated considerable interest among researchers, theorists, and policy makers in the issue of school safety. It seems clear that the educational and socialization functions of schools are compromised when the basic safety needs of the students are unmet; but those functions are also compromised when there exists in the student body a large unmet need for physical health, mental health, and social services. The long-term social outcome of unhealthy school climates is unclear, but it is difficult to imagine that those climates will produce healthy and optimally functioning adults.

There are a number of strategies implemented by schools in order to address safety, physical health, mental health, and social services needs, but in fact those strategies are often directed at only one or two of those needs and often result in the school being underserved. Population growth in many areas has rendered the traditional counselor/school psychologist model impractical for dealing with the kinds of mental health and violence prevention issues that arise especially in inner-city schools, and some attempts to work within the existing infrastructure may do more harm than good. As an example, Elliot Aronson (2000) reports that, following the Columbine shoot-

ing, his grandson's principal distributed a memorandum requesting that students make a note of and report any students who dressed oddly, were loners, or demonstrated some sort of maladaptive behavior - in essence, recruiting the student body to make the sort of mental health judgments that would ordinarily have been the province of school counselors or psychologists. Such lists might well have served to further alienate already marginalized students; Aronson, a prominent social psychologist, was displeased.

There is also evidence to suggest that punitive disciplinary responses to school climate difficulties are largely ineffective, and that a preventive orientation is preferable (Skiba & Peterson, 2000). It seems as well that broader preventive orientations are better than narrow ones, though narrow ones are more often implemented. A survey of articles about violence prevention interventions published between 1993 and 1997 found that only one-third of those intervention programs attempted to change the school environment or other non-classroom settings, though in elementary school those interventions that did attempt to change the school environment were more successful at reducing violent behavior than

the interventions that made no such attempt (Howard, Flora and Griffen, 1999); in fact, interventions that are solely curriculum-based are unlikely to be successful (Tolan & Guerra, 1994). In addition, it seems likely that effectiveness is increased by the inclusion of elements promoting healthy relationships and environments (Nettles, Mucherah, and Jones, 2000). For this reason, the concept of wellness is a valuable component of interventions designed to reduce school violence and drug and alcohol abuse. A shift in emphasis from risk to wellness brings with it certain conceptual reformations. To begin with, it shifts focus from identifying and treating at-risk children to helping all children to attain smooth developmental trajectories. However, the concept of risk is not abandoned; the wellness model also emphasizes the importance of identification of children at risk for negative outcomes, and the early identification and prevention of psychological and social difficulties. Finally, at the school level the wellness model implies that the school will make a commitment to enhancing the health, happiness, and quality of life of its students by encouraging civil discourse and discouraging bullying and exclusionary behavior.

The Healthy People/Healthy Places project (HHP), funded by the Office of Juvenile Justice and Delinquency Prevention, represents the concerted effort of the Riverside Unified School District, the Riverside County Mental Health Department, the Riverside Police Department, the Riverside Probation Department, and the University of California at Riverside, and is directed at the reduction of children's violent behavior and drug and alcohol use using a wellness model. The basis for this particular wellness model is the Development and Risk Together model (DART; Williams, Guerra, and Elliot, 1998), which takes a three-pronged approach to intervention. The first prong is to map out an appropriate developmental trajectory using physical, academic, and social milestones; the second is to identify those milestones or tasks that, when not accomplished, place children most at risk for problem behaviors; and the third is to identify risk factors that are not affected by development (such as socioeconomic or demographic characteristics).

The implications of the DART model for problem behavior intervention is fairly clear. In order to

design an efficient intervention, one must first know not only what behaviors to eliminate in order to restore children to healthy functioning, but also what exactly that healthy functioning looks like. One must also know which developmental tasks are danger signals when not accomplished and which ones can be safely glossed over, so as to direct one's energies efficiently. Identification of nondevelopmental risk factors can contribute to an understanding of the life circumstances that may lead otherwise healthy children to come to school distracted, anxious, or depressed. In order to be maximally effective, an intervention must be designed with all these variables in mind.

Following this model, the HHP project has targeted five schools in the Riverside Unified School District to be the location of Wellness Centers, the purpose of which is to promote healthy lifestyles among students and their families and to lower the incidence of violent behavior and drug and alcohol use by students. Each Wellness Center is staffed by a team consisting of a family advocate, a probation officer, a licensed clinical social worker, and a probation officer; the Centers provide services in the form of after-school activities, assessment and evaluation, counseling, referrals to social and mental health services agencies, family outreach, and case management to assist families in navigating California's social services system. In addition, the project will encourage community involvement through parent and neighborhood education outreach. The assessment component of this project is large-scale and uses both self-report and archival data to address the following issues: What are the environmental, developmental, and cognitive factors associated with school violence and problem behaviors; what are the predictors of improvement in developmental milestones, attitudes toward violence, and adaptive cognitions; and what types of children are most likely to benefit from the Wellness Center services. These issues will be addressed in part by administering a school-wide Wellness Survey yearly to children in selected grades. This survey will contain measures of attitudes toward violence, empathy and perspective-taking, cognitive distortions, goal-setting, and depression and anxiety.

ety, and is designed to be balanced between the assessment of negative behaviors or cognitions to be improved upon and the assessment of positive developmental milestones to be fostered. In addition, archival data containing school and community variables such as crime rate and housing information will be gathered in order to construct a comprehensive multilevel model of problematic behaviors and factors contributing to their amelioration.

Though maladjusted school environments do often produce well-adjusted children, they do so against great odds and for reasons not readily understood, and not nearly often enough in any case. The HPHP project is an attempt to delineate the factors that make for healthy school environments, school-community relations, and student relationships, and that reduce the incidence of school violence and other forms of maladaptive or inappropriate behavior. It is to be hoped that the project will show the wellness model to be a powerful tool in decreasing the rate of school violence and maladaptive behaviors so that the school's functions of education and socialization can proceed as unimpeded as possible.

2001 ASC GENE CARTE STUDENT PAPER COMPETITION

We invite participation in The American Society of Criminology Gene Carte Student Paper Competition. These awards are given to recognize outstanding scholarly work of students. Following are the procedures for the 2001 competition.

WHO IS ELIGIBLE

Any student currently enrolled on a full-time basis in an academic program at either the undergraduate or graduate level. Persons who are previous first place prize winners of this competition are ineligible.

SPECIFICATIONS FOR PAPERS

No paper may be submitted to more than one ASC student competition for the same year. Any paper that has previously won any prize in any ASC competition is ineligible for submission to another ASC competition. Papers may be conceptual and/or empirical but must be directly related to criminology. Papers must be typewritten, double-spaced on 8-1/2 x 11 white paper, and no longer than 7,500 words. The CRIMINOLOGY format for the organization of text, citations and references should be used. Authors' names, departments and advisors (optional) must appear ONLY on the title page, since papers will be evaluated anonymously. The next page of the manuscript should include the title and a 100-word abstract. The author must submit EIGHT copies of the manuscript, accompanied by a letter indicating the author's enrollment status and co-signed by the dean, department chair or program director.

PROCEDURES FOR JUDGING ENTRIES

International Criminology: A Survey of ASC International Members and Meetings Attendees

The need for the survey and how it came about

In 1999, the members of the ASC Subcommittee for International Membership, a division of the ASC Membership Committee, set out to discover ways to increase international membership and to increase international participation in annual meetings. To that end, the members of the Subcommittee, Heather Strang (chair), Susette Talarico, and I, designed a survey which was then administered to non-US attendees of the 1999 ASC meetings in Toronto. Having received not as plentiful a response as we had hoped and having decided that we need to survey international members of the ASC in addition to international attendees, we administered the survey a second time to all ASC members living outside the United States.

For the Toronto study (Survey I), the survey forms were inserted in the registration packets, requesting that non-US residents fill them out and return them to the ASC registration desk or return them by mail to ASC headquarters in Columbus, Ohio. For the international membership study (Survey II), the survey forms were mailed after the 1999 meetings, sent to all ASC members not residing in the United States, with instructions to return the completed forms to the ASC.

As of August 2000, the total number of members of the American Society of Criminology is 2895. The total number of international members is 455 (182 of whom are Canadian) making the international membership 16% of the total ASC membership. Our survey of international attendees at the 1999 meetings drew 44 respondents, representing 10% of the total international membership. Seventy nine (79) international members responded to our mailed survey, comprising 17% of the international membership.

I have analyzed both data sets and am herein reporting the general findings. If anyone would like to see the more detailed report submitted to the ASC Board and to the chair of the International Division, the data tables, or survey forms, please do not hesitate to contact me at the address below.

Before proceeding with the findings, bear in mind that the survey respondents overlap to some extent. That is, the respondents to Surveys I and II are not mutually exclusive.

What We Found

Both of the surveys describe the international attendees and members in terms of age, gender, and country of residence. More importantly, we are able to tell you the respondents' extent and type of participation in the ASC, barriers to full and effective international involvement with the ASC, and respondents' suggestions to improve ASC-international interaction.

As to who the respondents are, the respondents in both surveys are mostly male, mostly over 36 years old, and mostly Ph.D.s. Interestingly, the respondents from Survey I (meetings attendees) have a greater representation of women (34% compared to 23% of international members), are younger (9% aged over 55 compared to 29%), and are less likely to be Ph.D.s (61% versus 78%). The explanation that leaps to mind is that meetings attract students (fewer Ph.D.s and younger people) and that, due to long term sexism culture-wide, women have been excluded from higher education until relatively recently in world history. The annual meetings are useful settings in which to connect with potential employers and to have one's work recognized... which is quite relevant for those who are not yet established in the discipline, such as students.

The great majority of the respondents in Surveys I and II list universities as their institutional affiliation (73% and 80% respectively). And over half of them are residing in Europe (57% among attendees and 52% among members), plus a healthy number of Canadian residents (20% of the Toronto attendees and 13% of the members). Respondents across the Pacific are represented most heavily by Australian residents (11% of attendees and 8% of members) followed by a smattering of Japanese, Chinese, Taiwanese, Korean residents (the latter three groups were not represented at the meetings). Respondents also include a few residents of South America, Africa, the Caribbean, and Israel. Understandably, the list of countries is smaller for Survey I than for Survey II, a point which will receive more attention in a moment.

There are other national criminological associations outside of the US. Most of the respondents were aware of their existence, could list their names, but did not necessarily belong to criminological associations besides the ASC. While 84-85% of the respondents knew of such associations, 52% of the meetings attendees and 71% of members belong to them.

International participation in ASC. All of the Survey II respondents are (obviously) members of the ASC but only 61% of the Survey I respondents are. Of those who are members, the ranges for years of membership are 1-25 for Survey I and 1-35 for Survey II; the modes are 1 year and 5 years respectively; and the means are 8.29 years and 11.05 years respectively. In short, there are more new members, with less of a range and a smaller mean of membership years for the Toronto attendees. This is not surprising given that Survey I respondents are younger and less established (fewer Ph.D.s, indicating that they may not have been in the profession as long as the Survey II respondents).

The respondents were asked what they consider to be the advantages of membership in the ASC. Both sets of respondents listed receiving the ASC publications, *Criminology* and *The Criminologist*, as a prime advantage (28% of the members and 45% of the attendees).

An additional 13% of the members and 16% of the attendees find the ASC conferences to be a big advantage of membership; interacting with other criminologists, as well as participating in other conference activities, serve as big pluses. Membership also allows the respondents to keep up to date on the latest developments in US and international criminological research: 12% of the attendees listed keeping up to date as an advantage as did 26% of the members. Other advantages include the status that comes with being associated with the ASC (described as *the* preeminent criminological organization in the world), and affiliation with the divisions of ASC (international division, critical division, women and crime division, etc.).

As to conference attendance, about one-third of the respondents attend ASC meetings every year (32% of Toronto attendees and 35% of members). A greater proportion of the Toronto attendees, as less established conference-goers, stated that the 1999 meeting was their first meeting (41%) and 25% attend every second year or less frequently. Recall that the Toronto attendees are more likely to be Canadian than the respondents in Survey II, and therefore (probably) took the opportunity to attend the meetings because the meetings were local. Conversely, 54% of the members say they attend every second year or less frequently, and 10% have never attended an ASC meeting. Not unexpectedly, travel costs, jet lag, the extra time it takes for non-US residents to get to North America, etc. keep some international criminologists away from the ASC meetings.

The greatest problem in deciding whether or not to attend the ASC conferences, according to the respondents, has to do with the cost and, correspondingly, the lack of funding: 34% of the members and 41% of the attendees indicated that cost issues are the greatest determinant of their conference attendance. For the greatest proportion of respondents, travel is paid partly by their workplace and partly out of their own pockets (37% of Survey I respondents and 50% of Survey II respondents). The workplace pays the entire travel costs for 34% and 39% of the respondents. And 17% and 9% of respondents pay all of their own travel expenses.

Other major considerations for conference attendance are lack of time generally (20% and 17% for Survey I and Survey II respondents), taking time away in November (16% and 17% respectively), and the distance necessary to travel (19% and 21% respectively). Over half of the respondents did not have a preference for ASC sites, 52% in both data sets. For the sake of being redundant, I suppose, we asked the respondents if any meeting locations pose special problems for them, to which the vast majority said "no" (87% of members and 82% of attendees). Of those who do have a preference for meeting sites, the US east coast was designated as the preferred site (20% and 17% for Surveys I and II), followed by the US west coast (13% each), Canada (6% and 10% respectively), and so on with smaller numbers. Not surprisingly, respondents who do list a preference for meeting sites select sites of geographical proximity to themselves; Europeans prefer the east coast, Australians prefer the west coast, Canadians prefer Canada. But, overall, plenty of international members and attendees come to the meetings regardless of location.

While at the meetings, the respondents mostly give papers (61% of the members and 43% of the Toronto attendees) and far less often chair sessions and organize panels. As noted in open-ended questions about problems international respondents have experienced with the ASC, one of the criticisms is that they are not granted the opportunity to chair sessions and organize panels. I am unfamiliar with the precise mechanisms by which chairing and organizing duties are assigned but, apparently, international people are excluded from this activity in which some (at least) would very much like to participate.

Concerns, Problems, and Suggestions. The respondents were asked if they have experienced any communication difficulties with the ASC and, for the most part, they have not. Fifty five percent (55%) of the Toronto attendees said they had had no such problems as did 47% of the members. An additional 27% of each set of respondents answered that the question was not applicable or did not answer the question. (As with the other open-ended questions, the absence of an answer *might* mean that the respondents have had no communication or other problems but I don't want to jump to conclusions.) Twenty five percent (25%) of the members and 18% of the attendees did have communication difficulties and these difficulties primarily have to do with late arrivals of journals and other mail. The respondents also cited some problems with getting responses from ASC headquarters, especially without Internet access. Telephone and faxes are not always workable solutions to communication difficulties because of the time differences, and international snail mail is terribly slow.

The respondents were asked if they have had any other difficulties with the ASC. Forty two percent (42%) of members and 41% of attendees did not answer this question, and about half stated that they had not experienced any difficulties (46% of members and 48% of attendees). Eleven percent (11%) of each group said they had had difficulties and spelled these out as language barriers, problems with the Listserver, a need for book reviews to be published in the ASC outlets (*Criminology* or *The Criminologist*), and a rather troubling problem of US-centrism. As to the latter, in both surveys, the respondents pointed out that their papers are relegated to "international" sessions at the ASC conferences. That is, their papers are lumped together with papers by other international people, regardless of subject matter, resulting in a jumble of paper presentations without a coherent theme. Moreover, the respondents state that their sessions are slotted for low-attendance times (early morning, Saturdays) and are not attended by US criminologists.

I cannot state strongly enough that some of the international respondents have a feeling of *being left out*. An indication of this feeling of marginalization is revealed in the answers to Survey I question. The Toronto attendees were asked, "In general, do you feel that the interest of American scholars in overseas (non-American) research is ..." much less, somewhat less, about the same, somewhat more, or much more than in American research. Forty eight percent (49%) of the respondents answered that US scholars are somewhat less interested in international research than US research and an additional 41% answered that American scholars are much less interested in international research, for a total of 89%. None felt that international research attracted more interest than American research. Returning to the respondents' remarks about lumping international papers together, it may be out of ignorance that ASC program people lump international papers together, thinking that papers by Russian, Japanese, Italian, and other international scholars should go together simply because they do not address US research issues and findings. We must be reminded, however, that these international papers, as with papers by US scholars, address greatly varied topics of criminology, such as corrections, police behavior, drugs, sex offenses, etc. And what international scholars find about drug offenses, imprisonment rates, etc. is not irrelevant to what US scholars have to say about it.

The concern that US conference-goers do not attend sessions with international research or international themes is harder to fix because it requires an attitudinal and behavioral change. It may be bitter medicine, for those of us who consider ourselves diversity-minded, to discover that we marginalize. Nevertheless, we must take this judgement and advice in the spirit of professional advancement. As individual criminologists and as a discipline, we are engaging in anti-intellectual thinking if we do not learn all we can from the available domestic and international wealth of knowledge.

Finally, the respondents were asked if there are ways in which the ASC might better accommodate international members and attendees. About half (53% of members and 50% of attendees) did offer suggestions. Some of these suggestions were of a very pragmatic nature: encourage the use of slides, handouts, and power-point presentations (at conferences) to reduce language barriers; improve and expand Internet and email use; improve snail mail service if possible; do something about exchange rate disparities; and so on. Some of the suggestions were attitudinal, namely that the ASC should drop its ethnocentric practices. Among the other excellent recommendations were to increase the use of international activities at the annual meetings; for example, have more informal meeting opportunities like the British Home Office Tea. We might host more International Division activities, have an international theme to one of the conferences complete with prominent international speakers, and (very salient to all of us) have more informal networking opportunities. Of course, there is only a limited amount of time for the ASC conferences. The respondents rightfully point out, though, that brainstorming can occur during coffee breaks and other spots of time during which we, as criminologists, can *talk*. The ASC as an organization and its meetings provide, at their optimum, intellectual meeting grounds.

I certainly don't want to leave you with the impression that the respondents were full of complaints. Nothing could be further from the truth. The ASC might not be able to do much about bothersome mechanical difficulties (like slow mail). And aside from the helpful and workable suggestions for expanded email service, improved conference program planning, reduced US-centrism, and the like, the respondents seem to very much enjoy the conferences, the publications, the networking, and so forth. The respondents were also highly complimentary of our own Sarah Hall, who, through her skills, patience, and hard work, is largely responsible for the efficiency with which the ASC operates

Final Words

We can not say how the international samples differ from US members of the ASC in terms of their needs. We may all share some of the same problems (lack of travel funding) and desires (a need for more networking). But that requires another study. In the meantime, we have some fixable problems of an international nature to tend to.

In closing, allow me to express my deepest gratitude to the international attendees and members who diligently filled out the survey forms. I also want to thank my fellow committee members, the ASC Board, and especially Sarah Hall.

The **FIRM DEADLINE** for submission is **March 1, 2001**. **LATE SUBMISSIONS** should be submitted to Valerie Jenness or Richard Leo. They will not be considered for panel sessions. Late submissions will be organized into "Table Sessions" in which groups of scholars present their papers to each other (and others who want to join the table). **No submissions will be accepted after June 5, 2001.**

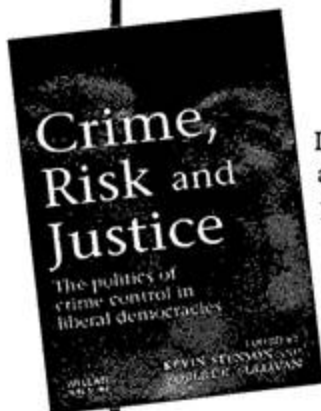

EDWIN H. SUTHERLAND AWARD WINNER

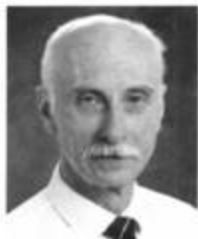
NORVAL MORRIS



Norval Morris, Julius Kreeger Professor of Law and Criminology, Emeritus, University of Chicago. Professor Morris was born in Auckland, New Zealand, in 1923. Following service in the Australian army from 1941 to 1945, he completed his LL.B and LL.M degrees at Melbourne University. In 1949 he received a Ph.D. in law and criminology from the London School of Economics, London University, and was appointed to the faculty. Subsequently he practiced law as a barrister in Australia and held academic appointments at Melbourne and Adelaide Universities in Australia, and at Harvard, Utah, Colorado and New York Universities. Immediately before joining the faculty of law at the University of Chicago, he was the foundation director of the United Nations Crime Prevention and Treatment Institute in Tokyo, Japan. Professor Morris is a Fellow of the American Academy of Arts and Sciences. He has written extensively on the criminal justice system, his last four books being Madness and the Criminal Law (1982), Between Prison and Probation (1990) with Michael Tonry, The Brothel Boy and Other Parables of the Law (1992) and the Oxford History of the Prison (1995) with David Rothman.

AUGUST VOLLMER AWARD WINNER

WILLIAM J. BOWERS



William J. Bowers, (Ph.D., Columbia University, in Sociology, 1966; B.A. Washington and Lee University, in Political Science and Economics, 1957) is now Principal Research Scientist in the College of Criminal Justice at Northeastern University, responsible for the development and administration of research on law, crime and justice. He was formerly director of the university-wide Center for Applied Social Research at Northeastern University (1979-1988). Since 1990, he has served as Principal Investigator of the NSF funded Capital Jury Project (CJP), a national study of how capital jurors make their life or death sentencing decisions. This study is unique in its collaboration among investigators, scope of data collection, and breadth of issues addressed. Investigators from 14 participating universities in as many states have conducted 3-4 hour structured interviews with 1,155 jurors from 340 capital trials. Since its beginning, the CJP has been the subject of annual sessions and presentations at the American Society of Criminology and the Law and Society Association. Some 20 scholarly articles drawing on the CJP data have so far been published. The CJP is challenging the U.S. Supreme Court's assumptions about the decision-making of capital jurors and has attracted the attention of the legal and academic communities, the U.S. Supreme Court, and the media. In June 2000, he began directing an NSF supported extension of the CJP project that will focus intensively on race of juror in capital sentencing. He is the author of research articles on arbitrariness and racial bias in the imposition of capital punishment, the deterrent or brutalizing effects of executions, the attitudes and policy preferences of citizens and legislators concerning punishment of murder, and two books on capital punishment, Legal Homicide: Death as Punishment in America, 1864-1982, Boston: Northeastern University Press (1984), and Executions in America, Lexington, MA: Lexington Books, D. C. Heath and Company (1974). His most recently published articles include, "Foreclosed Impartiality in Capital Sentencing: Jurors Predispositions, Guilt Trial Experience, and Premature Decision Making" 83 *Cornell Law Review*, 1476 (1998); "Death by Default: False and Forced Choices in Capital Sentencing" *Texas Law Review*, 605 (1999); "Folk Knowledge as Legal Action, Death Penalty Judgments and the Tenet of Early Release in a Culture of Mistrust and Punitiveness," *Law and Society Review*, 461 (1998), and Death Sentencing in Black and White: An empirical analysis of jurors' race and jury racial composition, to be published in *Journal of Constitutional Law* (UPenn). He has appeared as an expert witness in 26 capital cases (1976-1991) and testified on death penalty legislation before committees of the U.S. Congress and the Massachusetts legislature.

PAT O'MALLEY



Pat O'Malley (Ph.D., London School of Economics) is Professor of Law and Legal Studies, Deputy Dean, and Research Dean of the Faculty of Law and Management at La Trobe University, Australia, and was formerly Director of the National Centre for Socio-Legal Studies and President of the Australasian Law Teachers' Association. He has been Lurcy Lecturer at Amherst College, Massachusetts, (1992), John Llewellyn Edwards Scholar at the Centre of Criminology, University of Toronto (1996), and a Centenary Lecturer at Victoria University of Wellington, New Zealand (1999). Research has ranged widely across criminology and 'law and society', including historical, theoretical, fieldwork, and policy research, with a unifying focus linking social and criminological theory to politics and policy. In the last ten years, this has focused on risk and government, especially to do with crime and criminal justice, and currently is a consultant to the state Government of Victoria on this issue. Recent publications in this field include *Crime and the Risk Society* (1998), *Crime Prevention in Australia* (1997) with Adam Sutton; and a special edition of *Economy and Society on Configurations of Risk* (2000). Current work focuses on illicit drug policy. He is a member of the Victoria Government's Drug Policy Expert Committee and was previously on the Premier's Drug Advisory Council (1995-96) which provided the blueprint for Victoria's progressive harm minimisation policies. He is married to Margaret Foddy and both of them work much too hard.
