ONE CRITICAL CRIMINOLOGIST'S VIEW OF THE FUTURE AND VALUE OF ASC

I have already used this story in the preface to a textbook, but luckily it has been carefully explained to me that no one ever reads textbook prefaces (and the book wasn't all that great a seller anyway) so it is still a fresh story. Sharon McCrumb, one of my favorite writers, has a series of mysteries starring a forensic anthropologist named Elizabeth MacPherson. In one story, the question comes up as to whether Elizabeth had undergraduate training in criminology. She admits to taking a criminology class because it sounded exciting. "Actually, it's deadly dull. Mostly statistics" (1991, p. 170).

In some degree, this is the good side of the Division on Critical Criminology. Personally, I am a bit odd there as I have been known to use logistic regression and other abstruse statistics, but for the most part critical criminologists tend to look at broader issues and raise overarching questions. We may be deadly dull, but it won't be because there are too many statistics. I will get back to this later.

For now, this ties in to Todd Clear's vision of the future of the ASC as a whole. He worries that ASC has had a rather minimal presence on the national policy making scene. This could not be truer. A colleague recently remarked to me that one thing we could do is to deal with the erroneous belief held by The New York Times that the only criminologists now active in the United States are Alfred Blumstein and James Alan Fox. I am not attacking their work – I assigned materials by both to two classes this spring. Nor is the statement literally true. But it does reveal a tendency of the media to head for people with top reputations who can be counted upon both to provide statistics, and also to represent a mainstream point of view.

Todd worries that the membership would not appreciate taking sides on public policy decisions. While this might be occasionally true, it hardly seems that there are no issues where we could not have the consensus of at least the broad majority of ASC members. Perhaps I heard the wrong papers, but in my 25 years of ASC membership I have no memory of extensive talk arguing in favor of locking up more young minority males, bankrupting governments in order to raise the number of people imprisoned overall by an amount that was inconceivable 30 years ago, increasing drastically the use of the death penalty, using long prison terms for minor offenses, effectively ending prison college education programs, bringing back chain gangs, and dozens of other public policy decisions taken across the United States. The ASC could easily have been in the forefront of public policy debate on all of these issues. Truthfully I think that the membership is more likely to be split on issues such as what cities to meet in than on issues such as the need to lock up minor drug offenders (but not alcohol abusers who kill people, such as DWIs).

Recently Barry Glassner (1999) and Joel Best (1999) have each published excellent books on America's top product for export to the rest of the world: the fear of crime. We have long discussed how America's politicians and media can increase the fear of crime by constantly portraying the streets as places of massive danger. What is particularly interesting is that people who live in countries with lesser crime problems (Canada, Australia, Europe) watch American television shows, read American books, see American politicians, and suddenly begin to panic about crime.

While both Best and Glassner have excellent analyses of how crime fears that are irrational or nonrational come about and are maintained, what is particularly important is the extent to which these fears take us away from things that we need to worry about. These fears are very widespread. For example, Joel Best has written about the long-lived American fear of an initiation rite

among gang members that requires them to drive around at night with their lights off, and if anyone blinks their lights at them, to turn around, run down that car, and kill everyone in it. The simple problem that this has never happened in our massive country, has not stopped police departments, church groups, politicians, businesses, and others from spreading the word as fast as possible. Recently I lectured to social work students in Switzerland, and mentioned the myth. Not only had they already heard of it, but one woman told me that she had just received an e-mail from a South African friend who reported the deep fear there about the new youth gangs operating in just this way. It isn't only Eminem and Brittany Spears that we are exporting.

So, it is a fascinating question for sociologists as to why it is that we insist on believing in every myth without facts that comes down the pike. I recently taught a graduate seminar on an outreach campus located in a small Appalachian community, and many of the students drove long distances from even smaller communities – the kind, as one student told me, where it was mandatory for all football players to play also in the band so that they could mount a halftime show. Yet, they reported that as parents they always had Halloween candy x-rayed, refused to eat a certain brand of chicken because of an old myth about a rat getting fried and served, demanded high levels of security in their schools, and never, ever, under any circumstances signaled anyone that their headlights were off.

Perhaps the most interesting panic to sweep the United States is the worry over violence in schools. Certainly no news media is broadcasting the fact that school violence, and in particular homicides, are at an all time low in America. Rather, we are now spending hundreds of millions of dollars, if not billions, on security guards, metal detection devices, security cameras, mandatory identity cards on neck cords, bans on book bags not made of clear plastic, and much more.

Even schools that rarely have the money to fix leaking roofs, rarely have the money to purchase library books, and certainly don't have the money to hire a sufficient number of trained teachers have come up with the money for security guards. With over 50 million children in the U.S. attending more than 110,000 schools, the 20 to 40 homicides a year in schools from all causes hardly seems to warrant the news media rant that killer kids are now an epidemic.

The important issue, and one that Glassner spent much time discussing, is very relevant to me here in Appalachia. In a country where almost a quarter of all citizens are functionally illiterate, where the school dropout rate is close to one-third of all children, and where as many as two million children a year are homeless for some part of the year, is it possible to argue that there are more important uses for our money than hiring overweight retired deputy sheriffs to wander the school-halls? Again, I mentioned this in Switzerland, and the class went into shock. The 55 undergraduates stopped for a few minutes, and no one could come up with the name of a single person they had ever known or heard about who did not complete high school. Is there some possibility of arguing that we might better put some of our money into education?

Ah, you ask, what happened to the ASC? What is our role here? As sociologists (which nearly half of us are) we LOVE to spend our time demythologizing what everyone else thinks. Why are criminologists not in the forefront of arguing that killer kids are NOT America's greatest problem? Our problem is that more than ten percent of American kids are malnourished. We sit in criminology class and talk about several dozen theories that suggest that malnourished, uneducated, unloved children with no job prospects are more likely to commit street crime. With all due respect for some of our neo-classical thinkers, it is my belief that the overwhelming majority of ASC members would agree that stealing money from the security industry and putting it into feeding and educating our children would have a great payoff in terms of street crime rates.

INTIMATE VIOLENCE. Worst of all, although this is an issue that is beginning to garner some attention, for most Americans stranger violence is not the event to fear. Rather, it is intimate violence. Most rapes, most beatings, and for women most homicides are committed by friends and intimates. As someone who has taught a course dual listed with women's studies on rape since the late 1970s, I have heard and counseled a great many women. In that time, I have heard about as many women raped by their safety escorts as I have college women raped by strangers.

We spend a great deal of time worrying about cyberporn and its effect on children. While the news media and politicians have been active in fear mongering on this issue, we have strongly ignored the simple facts that criminologists have known all along. Child molesters found numerous victims long before anyone invented a chat room, and more importantly most sexually abused children are abused by a member of their own family. Further, poor children, with the least access to the Internet, are the most likely to be abused.

WHAT DOES CRITICAL CRIMINOLOGY HAVE TO OFFER? As with all interest areas, there is no real possibility of representing an enormous school of thought coherently. Critical Criminology is really an umbrella term that covers a broad range of viewpoints. While many can trace their heritage into the roots of radical criminology, that really is the smallest branch of the tree today. Critical criminologists include a wide variety of left of center theorists, including left realists, postmodernists, peacemaking criminologists, feminist criminologists, and quite a number of various combinations and smaller strains of thought. For example, among the leaders of the division both I and Walter DeKeseredy work mainly in violence against women, David Friedrichs is an expert on corporate crime, Jeff Ferrell deals in cultural crime and has written extensively on graffiti artists, Meda Chesney-Lind and Karlene Faith work with women and girls in conflict with the law, Jody Miller with gang girls, Bob Bohm on capital punishment and both Jeff Walker and Mike Blankenship have recently published statistics textbooks. Todd asked that these essays not try to represent the views of the division, but in my case this would be pretty difficult under any circumstances.

Where we have been different over the years has been that as a broad and general statement critical criminologists have looked at larger and broader questions, rather than narrow ones. Few critical criminologists worry about failure rates in day reporting centers or the development of an equation that would predict success in small town COPS programs.

Critical criminologists have begun to worry that these processes are beginning to accelerate with the development of a global economy. As international financial institutions begin to take actions that enrich themselves with the result of an impoverishment of large segments of people in developing countries, some critical criminologists have begun to worry about definitions. The great historian Henry Steele Commager many years ago pointed out that in American law it is the burning down of a small hut that is a crime, but not the wanton destruction of the almost irreplaceable redwood forests by international companies.

So, one action we could be taking is debating over what actions taken by governments could be considered crime. Presumably this is not the American Society of the Study of Interpersonal Crime by Powerless Individuals? Even there, of course, there are critical criminologists (at least in Australia) beginning to write on questions such as the impact of globalization on street crime.

There are other new developments to be worried over, such as the development of transborder crime and transnational crime. How do our traditional methods of studying crime allow us to understand these behaviors?

Of course, all members of ASC, no matter what country they live in or what their political or scientific bent, are welcome to membership in our division --- or at least to our free social at the meetings.

TODD'S SPECIFIC POINTS. Not to belabor the ongoing "me too" nature of these essays, it just might be worthwhile to underscore a few points.

First is the new trend toward having divisions put out their own refereed journals. This is an expensive and difficult effort, but it may be essential to the future. Bluntly, *Criminology* is very difficult to break into, as is *Justice Quarterly*, and articles must be written in a certain format to have any chance of success. As any editor of these journals can tell you (and possibly already have!), there is a perception among the membership that these journals are antagonistic toward women, minorities and critical criminologists. Personally, as a former deputy editor of *JQ* and an editorial board member of *Criminology*, and someone who has published in both, it is my view that it isn't really content that keeps people out of these journals. Anyone who can write like Frank Cullen will be taken seriously, no matter what his or her politics. Even if they are right wing, semioticians, theoreticians without data, philosophers, and others will have trouble getting into these journals. And that describes much of my division.

We have entered into an agreement with Kluwer Publishing of Holland to publish our journal, *Critical Criminology*, starting with Vol. 10, No. 1, which should be out shortly, with Jeff Walker as editor in chief, Paul Leighton as North American editor and Jock Young as European editor. John Fuller and Jayne Mooney will be American and European book review editors. We have established a 30 member editorial board of some of the top European, North American and Australian scholars, and hope to establish exactly what ASC wishes -- stronger relations and idea stimulation between these women and men.

Other divisions no doubt have their own stories to tell, but we at least think that articles on people of color that are more than statistical manipulations of the effect of race on the system, or feminist analyses that go beyond violence against women studies (ouch, that hurt me) are still deeply needed in the field.

Finally, it is always instructive to see how times change. Close to 20 years ago I was annoyed at the poor quality of ACJS annual meetings and wrote a partially sarcastic piece of humor, and partially dead serious paper I delivered the next year on the delivery of scientific papers at annual meetings. Perhaps I should have shared it with Todd then, because I note that many of

my suggestions are now appearing as new ideas. One was that papers that are ACTUALLY WRITTEN be coded with some symbol, or that panels of such papers be coded, so that persons would know whether there was some effort that had gone into a paper or whether it had been written on a cocktail napkin at lunch.

I suggested that it was **outrageous** that we were a criminology organization, propping up and maintaining a system of penalties for errant citizens, but that we did not sanction our own members for failure to show up at panels without notice, showing up with insultingly bad papers, or for late submissions. I was rather tongue in cheek, but certainly the biggest problem I have head has been scheduling similar panels opposite each other, scheduling international presenters at "ghetto" times, and a failure to get more people to just plain admit that they are doing "work in progress," or even "work I would like to get in progress," or "one minor idea I had to come up with so my dean would pay for my trip to San Francisco." Todd's ideas are strong, and I recommend that he be made 5-year chair of a committee to try to implement them.

EXECUTIVE BOARD SELECTS ST. LOUIS FOR THE 2008 ANNUAL MEETING

The ASC Executive Board recently selected St. Louis as the site of the Annual Meeting in 2008. While final negotiations will take several months, it is our intent to sign a contract with both the St. Louis Marriott Pavilion and the St. Louis Adam's Mark hotels. There was significant discussion at the ASC Mid-Year Board Meeting regarding allegations of systemic discriminatory practices being undertaken by the Adam's Mark chain. While the court dismissed the class action suit against Adam's Mark, we felt some need to follow up on the matter. Chris Eskridge contacted officials within the Adam's Mark corporate structure, the St. Louis Convention Bureau, and both the St. Louis chapter and the national office of the NAACP. A number of documents and materials were provided ASC. We learned that the entire Adam's Mark chain was recently audited by Project Equality, a national civil rights organization. This 3-month independent audit uncovered, "no signs of intent to discriminate," and gave the chain high marks for its "inclusiveness of women and persons of color."

After reviewing those documents and personally visiting with representatives from all of the above noted entities, we are satisfied that the Adam's Mark chain is functioning responsibly, and it is our intent to move forward and negotiate a favorable contract for our 2008 Annual Meeting. EUROPEAN SOCIETY OF CRIMINOLOGY

A number of European criminologists held an informal meeting at The Hague approximately one year ago, and resolved to organize a *European Society of Criminology (ESC)*. Over the last months, that Society has been formally established with an official seat at the Institute of Criminology of the University of Cambridge (UK). As the composition of the Board and the heterogeneity of its rapidly growing membership indicate, the ESC is emerging as a comprehensive, trans-European organization in the field of criminology.

The ESC will organize open conferences, with participation from colleagues across Europe, as well as from countries outside the European continent. As a general rule, the language used at the conferences will be English. Plans to create an ESC sponsored journal which will be distributed to all ESC members are currently under review.

The ESC meetings will become particularly useful as a platform for interaction and exchange for Americans wishing to make contact with European colleagues, just as the American Society of Criminology meetings have been of value to Europeans seeking contacts with Americans.

The first annual meeting will be held at the University of Lausanne, Lake Geneva (Switzerland), September 6-8, 2001. The 2002 meeting will be held at the University of Castilla-La Mancha at Toledo (Spain). It is planned to hold future meetings at various locations throughout Europe in an attempt to stimulate interest across the European continent.

DIVISION ON CORRECTIONS AND SENTENCING

Division members have been extremely active this year. Committees have planned feature panels and roundtables for the Atlanta Annual Meeting, recommended candidates for ASC awards, planned two Division awards (Distinguished Scholar and New Scholar), developed a website, completed the first newsletter (available on the web) highlighting six Division members, planned events for the Atlanta Annual Meeting, developed an official Division logo (see above heading), advertised the Division to other organizations and developed a student paper competition. Volunteers for committees are always welcome.

A special edition of the *Prison Journal* focusing on the topic of "Corrections and Sentencing in the 21st Century" will be published this year. The manuscripts will be based on papers presented at the roundtable sponsored by the Division at the 2000 ASC Annual Meeting.

At the 2000 ASC Annual Meeting the Division held a roundtable on the topic of "How to Win Tenure in an Academic Institution." Prior to the roundtable a manuscript was distributed and critiqued. The manuscript will be edited in light of the comments and will be available for sale the 2001 ASC Annual Meeting.

2001 ASC Annual Meeting. The Division Vice-President Pat Van Voorhis has organized five roundtables at the 2001 ASC Annual Meeting. Two of these roundtables will focus on educating ASC members about the Campbell Collaboration, systematic reviews and meta-analysis. Several feature panels are planned for the 2001 Annual Meeting.

Awards Committee (John Kramer and John Hepburn, Co-chairs). The awards Committee (Co-Chairs and Gaylene Armstrong, David Farrington, Alex Holsinger, and Meda Chesney-Lind) nominated candidates for the ASC Sutherland and Sellin-Glueck Awards. They are currently working on a list of nominees for the Division Distinguished Scholar and New Scholar Awards. They are soliciting nominations from members of the Division. They plan to have a list of nominees for the Division Awards by the end of April and to have made a decision by the beginning of June.

Website and Newsletter (Cindy Smith). The Division website is posted and ACTIVE (thanks to Cindy Smith). Biographies of the Division officers are available on the site. The Division newsletter will be published on the website. The first newsletter highlights six of our members (Todd Clear, David Farrington, John Kramer, Joan Petersilia, Christine Rasche, and Cassia Spohn (thanks to Spencer Li). The new official DCS logo (thanks to Jodi Lane) serves as an identification. The DCS Newsletter employment opportunity has been posted (thanks to Ken Adams). The student paper competition is advertised (thanks to Marie Griffin). We look forward to many comments and submissions from the membership to the website.

Special Event Committee (Gaylene Styve Armstrong, Chair). This year the Committee is planning the Division Awards Breakfast to be held Thursday morning at the ASC Annual Meetings. At the breakfast, a junior and senior scholar in the area of Corrections and Sentencing will be recognized for their contributions to the field. A nominal fee will be charged to attendees. Announcements will go out in a summer mailing to conference participants.

Outreach Committee (Jodi Lane and Crystal Garcia). With the assistance of Bob Schmitt (an experienced professional) the committee developed an official logo for the Division (the logo appears as the heading). Using the logo, a flyer was developed and inserted in the packets for registrants for the ACJS Annual Meeting. Currently the Committee is working on: (1) a brochure to be distributed to prospective members, (2) a banner for display on tables at the ASC Annual Meeting, and (3) Placing information about the Division in other societies' and organizations' newsletters.

Student Affairs Committee (Marie Griffin, Chair, Karol Lucken, Diana Gray, Jody Sundt, Shelley Johnson). The student affairs committee is currently advertising the Student Paper Competition. This award will be given to a paper judged to be outstanding in the area of research or theory in corrections and sentencing. Requirements are that it is: (1) a single authored paper, (2) unpublished at the time of submission and (3) not submitted to another ASC paper competition. The Committee will conduct the competition and select a recipient. The Committee would like to plan a student activity at the ASC Annual meeting.

The ASC Division on Women and Crime announces the 2000 Student Paper Competition which is intended to encourage excellent student writing on matters of feminist scholarship, gender issues, or about women as offenders, victims, or professionals. Any student currently enrolled in school at the graduate level at the time of submission is eligible to enter.

Papers must be no longer than 30 pages with an acceptable referencing format such as APA. Papers must contain an abstract of 100 words, be typed double spaced, and submitted on 8-1/2 x 11 paper. Three copies of the paper must be submitted along with verification of current student status. Include contact information in cover letter. Papers by multiple authors are acceptable as long as all authors are students. Papers must not have been previously published. The DWC Awards Committee will judge papers based on significance of the topic, conceptualization, and clarity of writing. The winner will be presented with a cash award at the annual meeting of the ASC. **Three copies of the paper must be received no later than September 8.** Please send all papers to:
