## WHEN GIVING IS THE REWARD: THE CASE OF THE AMERICAN SOCIETY OF CRIMINOLOGY AND THE UNITED NATIONS

In July 2001 the American Society of Criminology was granted Special Consultative Status with the Economic and Social Council (ECOSOC) of the United Nations. This entitles ASC to designate official representatives to the U.N. (New York, Geneva and Vienna) and announce this on its letterhead, contributing to ASC's prestige. We now join Amnesty International, Friends World Committee for Consultation (Quakers), International League for Human Rights, Centro Nazionale di Prevenzione e Difesa Sociale, Defense for Children International, Howard League for Penal Reform, International Society of Criminology, International Association of Penal Law, Pax Romana, Penal Reform International, Prison Fellowship International and World Society of Victimology, all regulars in the U.N. crime prevention and criminal justice work. Council Resolution 1996/31 elaborates the procedures for carrying out this consultative relationship as well as specifying the requirement to provide a report of relevant activities in 2006.

What exactly has ASC applied to do by seeking 'Special Consultative Status'? What's in it for ASC members and what of worth might the U.N. get out of this relationship? These are some of the questions the Division of International Criminology has been tasked by the Executive Board to explore for the next three years. Under the leadership of Rosemary Barbaret, Chair of the DIC, along with Chris Eskridge as Executive Director, and elected officers of the DIC (Liqun Cao, Bonnie Fisher, Nancy Grosselfinger, Cindy Smith and Alex Vazsonyi), and experienced U.N./ASC veterans (Freda Adler, Gerhard Mueller, Paul Friday) we have been reviewing documents, participating in meetings, taking notes and keeping records, observing dynamics, reflecting and holding strategy sessions, all in an effort to assess where and how ASC members could make a valid and valued contribution.

The most powerful venue for this contribution is the U.N. Commission on the Prevention of Crime and Criminal Justice (known as the Crime Commission), created by ECOSOC under Article 68 of the U.N. Charter in February 1992, to replace the previously existing arrangements which were more friendly to "individual consulting experts" such as ASC members might be classified. The Commission is comprised of forty Member States of the U.N., elected on the basis of equitable geographic distribution, for terms of three years. Member States are expected to (but might not) make every effort to ensure their delegations include experts and

**ERIC L. JENSEN**, professor of sociology, and Jorgen Jepsen, senior advisor to the Danish Institute of Human Rights co-organized a conference entitled "Youthful Law Violators, Human Rights, and the Development of New Juvenile Justice Systems" at the International Institute for the Sociology of Law in Onati, Spain, June 5-6. The topic of the conference was the creation of juvenile justice systems in developing nations based on the Convention on the Rights of the Child. The conference included invited participants from 10 nations. The co-sponsors of the conference were: the University of Idaho, the Danish Inst. for Human Rights, the International Inst. for the Sociology of Law, and the Center for Delinquency and Crime Policy Studies at California State University, Sacramento.

senior officials with special training and practical experience in crime prevention and criminal justice, especially with policy responsibility. Nevertheless, it is *not* usual to find criminologists in that mix.

The Commission has the power to create ad hoc working groups and to appoint special rapporteurs. It meets annually in Vienna for not more than 10 working days, and sometimes inter-sessionally on specific issues. Furthermore, ECOSOC rules provide that in addition to Member States, meetings of the Commission can be attended by Observer States (Member States not elected to the Commission), specialized agencies of the U.N., other intergovernmental organizations, and non-governmental organizations in consultative status. ASC is one of approximately forty organizations in the last category and, one of the few, along with the Academy of Criminal Justice Sciences, the International Society of Criminology, and the World Society of Victimology which would define their members as largely academic researchers and/or policy level practitioners.

The Crime Commission has been tasked to support the mandate of ECOSOC by providing policy guidance in crime prevention and criminal justice, to develop, monitor and review the implementation of programmes, to facilitate and help co-ordinate the actions of inter-regional and regional institutes (to be described below), to mobilize the support of Member States for the U.N. crime and criminal justice programs, and to prepare congresses and make suggestions regarding the programme of work for the U.N. in this area. It is *the* principle policymaking body of the U.N. in crime prevention and criminal justice.

The Commission is supported in carrying out its work by a phenomenal elite Secretariat, organizationally located inside the Office of Drug Control in Vienna, consisting of approximately 17 permanent U.N. civil servants, a handful of others 'on loan' from their governments, and student interns. Within the current (and former) staff are faculty and graduates of U.S. schools of criminal justice and scholars from other Member States, some of whom are ASC members and/or participants in the annual meetings.

Their recent activities include four Global Programmes, and the journal Forum on Crime and Society. They do all this within significant political, financial, and other constraints but with good cheer. They are *eager* for helpmates and gratefully received the infusion of ASC journals which Chris Eskridge provided their under-resourced library.

Additional support in carrying out the work assigned to the Secretariat by the Commission is the U.N. Crime Prevention and Criminal Justice Program Network (PNI), comprised of fourteen 'institutes' headquartered in Vienna, Turin, Tokyo, San Jose, Helsinki, Kampala, Riyadh, Canberra, Vancouver, Siracusa, Washington, D.C., Lund, Milan and Montreal. These institutes vary in their historical development, relationship to the Commission, personnel configurations and degree of activism. All are heavily influenced in their focus and activities by their funding sources, usually the national government where they are hosted, and by mutual agreement with the other institutes and the U.N. The ASC/DIC delegation to the Crime Commission in May 2003 in Vienna had contact with a representative of virtually every institute present. The strongest alliances thus far are with the Australian Institute of Criminology (Canberra), the Centre for International Crime Prevention (Vienna), European Institute for Crime Prevention and Control (Helsinki), National Institute of Justice (Washington), International Centre for the Prevention of Crime (Montreal), the United Nations Inter-Regional Crime Research Institute (Turin) and International Scientific and Professional Advisory Council (Milan).

In conjunction with the latter, in December 2002, Cindy Smith represented ASC at the four day meeting of ISPAC in Courmayeur, Italy. (Five other identifiable ASC members were also present.) The theme of this annual meeting was illicit transnational trafficking networks and logistics of crime and terrorism. Approximately twenty-three presentations were made to the forty-six attendees, only two from academics, all the others being high level practitioners or public policymakers. Only one was an ASC member, more or less typical of such a session where national origin (or representation) is a significant factor in programming.

ISPAC also plays a "coordinating" role with respect to the quinquennial U.N. Crime Congresses, the next of which will be celebrated in Bangkok from April 18-25, 2005. What ISPAC coordinates (in support of the Secretariat) for the Congress are the Ancillary Meetings wherein individuals who do not form part of Member States' official delegations (as experts), or PNI researchers can, through non-governmental organizations, find a venue in which to elaborate themes already encompassed within the rubric of the Congress established by the Commission, but also have the possibility of shedding light on *newly* emerging transnational crime prevention or criminal justice issues. U.N. General Assembly Resolution 46/152 (December 1991) stressed that *non-governmental organizations and the scientific community* are valuable sources of professional expertise, advocacy and assistance, and that their input should be maximized in programme development and implementation. Thus ISPAC plays a gatekeeper role in organizing participation at U.N. Crime Congresses.

Lastly, the Alliance of Non-Governmental Organizations on Crime Prevention and Criminal Justice, founded in 1972 by our own Gerhard Mueller, is yet another potential arena in which ASC members might make a contribution. The Alliance is comprised of a very loose coalition of approximately 40 U.S. NGO's many of whom have Consultative Status and all of whom claim an interest in crime prevention and criminal justice. Their stated purpose is to encourage the development of criminal justice practices and crime

prevention strategies which strengthen communities, respect the human dignity and rights of persons accused of, convicted of, or victimized by crime, and to protect and restore all involved. They seek to achieve this by providing two-way exchange of information and consultation with the U.N., by assisting in the identification of issues, providing research studies, recommendations for action and technical assistance in areas within their expertise, and by strengthening the collective services of the Alliance through exchanges of information and cooperation between members of the Alliance. The members of the Alliance are diverse, including the American Correctional Association, Prison Fellowship International, World Society of Victimology, the International Society for Traumatic Stress Studies, International Association Against Drug Abuse and Drug Trafficking, International Association of Penal Law and more. For the past year Cindy Smith has been representing ASC at the bi-monthly meetings of the Alliance, held in New York near U.N. headquarters. It is likely that most ASC members desiring to participate in the 2005 Congress will gain entrée via ASC through the Alliance and ISPAC.

So what does the U.N. talk about in "crime prevention and criminal justice"? Sometimes it is difficult to decipher because of the compromise language devised to encompass the multitude of interests and agendas. For example, the four themes of the last Crime Commission meeting in May 2003 were 1) trafficking in human beings, especially women and children, 2) international cooperation in combating transnational crime, 3) strengthening international cooperation and technical assistance in preventing and combating terrorism, 4) use and application of United Nations standards and norms in crime prevention and criminal justice. [See the DIC Fall Newsletter for greater detail.] Some of these themes are relative newcomers while #4 is perpetually on the U.N. agenda to the chagrin of some. Similarly, the title for the 2005 Crime Congress is Synergies and responses: strategic alliances in crime prevention and criminal justice. The thematic areas to be included are: 1) Effective measures to combat transnational organized crime, 2) Corruption: threats and trends in the twenty-first century, 3) Economic and financial crimes: challenges to sustainable development, 4) Making standards work: fifty years of standard-setting in crime prevention and criminal justice. In addition, U.N. style workshops are to cover: a) Enhancing law enforcement and criminal justice reform, b) Strategies for crime prevention, c) Measures to combat terrorism, d) Measures to combat economic and computer-related crime.

Within each of these over-arching descriptors are possibilities for input from all the participant sectors mentioned above, including the academic community or portions thereof, even opposing perspectives. While oral presentations must necessarily be brief in order to accommodate the many who wish to be heard, the potential for drafting resolutions (at the Commission), and circulating written position papers of the organization, which in our case could summarize research findings and recommendations, is more permissive, generally well-received and appreciated. Introducing *new* themes, problems or solutions can be handled within the NGO Alliance, pressing ISPAC or another institute for inclusion, or approaching the Secretariat directly for guidance. And there is *always* the possibility of collaborating with Member States, even one that is not your own, especially those experiencing difficulties (or success) in the subject identified.

The potential for individuals, as members of ASC, to give to the U.N. are limited largely by stamina and determination. The structures, as described above, are quite open and ASC has not yet built any further barriers, limitations or obstacles save the fact it provides largely "institutional support", not financial. The point of contact for ASC members is via the DIC which has the organizational duty to facilitate such participation.

The pay back or what you "get" in return must be judged by each individual of course. Participating in any of these U.N. related venues constitutes community service at the international level which many other professions do not provide or recognize. Contributing can give considerable gratification if you are patient enough to persevere and stay for the gain, sometimes as tedious as continuing in a drafting committee to enter a few significant words in a document which has been in process for several years, or being an advocate for an idea or practice which takes decades to catch on and be recognized. For example, Prison Fellowship International can take considerable credit for the meteoric rise of the notion of restorative justice within the U.N. Similarly the National Rifle Association has had influence over the content of a small weapons convention.

If you are pre-disposed to quiet negotiation and even more quiet satisfaction in seeing a job well (or better) done because of your input, and you have within you the language skills, cultural tolerance, and 'diplomatic personality' necessary to work productively in a venue with persons, customs and ideas which might be utterly repugnant to you, then your participation might be the ultimate reward.

You certainly will not enrich your purse. Even if you can find external financial support it is unlikely to be sufficient to regularly cover all your genuine expenses.

Perhaps the greatest gratification is the release of your passion for the field, wanting to 'make a difference' with your professional work. Converting your caring about how the world of criminal justice turns out into concrete, substantive effort, is the biggest pay back.

## STUDENTS - CALL FOR ENTRIES

### 2004 ASC GENE CARTE STUDENT PAPER COMPETITION

We invite participation in The American Society of Criminology Gene Carte Student Paper Competition. These awards are given to recognize outstanding scholarly work of students. Following are the procedures for the 2004 competition.

#### WHO IS ELIGIBLE

Any student currently enrolled on a full-time basis in an academic program at either the undergraduate or graduate level. Persons who are previous first place prize winners of this competition are ineligible.

#### SPECIFICATIONS FOR PAPERS

No paper may be submitted to more than one ASC student competition for the same year. Any paper that has previously won any prize in any ASC competition is ineligible for submission to another ASC competition. Papers may be conceptual and/or empirical but must be directly related to criminology. Papers must be typewritten, double-spaced on 8-1/2x11 white paper, and no longer than 7,500 words. The CRIMINOLOGY format for the organization of text, citations and references should be used. Authors' names, departments and advisors (option) must appear ONLY on the title page, since papers will be evaluated anonymously. The next page of the manuscript should include the title and a 100-word abstract. The author must submit EIGHT copies of the manuscript, accompanied by a letter indicating the author's enrollment status and co-signed by the dean, department chair or program director.

#### PROCEDURES FOR JUDGING ENTRIES

The Student Awards Committee will rate entries according to criteria such as the quality of the conceptualization, significance of the topic, clarity and aptness of methods, quality of the writing, command of relevant work in the field, and contribution to criminology. The Committee's award determinations will be final.

#### AWARDS

The 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place papers will be awarded prizes of \$500, \$300, and \$200, respectively and will be eligible for presentation at the 2004 meeting of The American Society of Criminology in Nashville, Tennessee, November 17-20, 2004. The 1<sup>st</sup> prize winner will also receive a travel award (generally hotel accommodations) to help defray costs for attending the Annual Meeting. The Committee may decide that no entry is of sufficient quality to declare a winner. Fewer than three awards may be given. Prize-winning students will be acknowledged at the Annual Meeting Awards Ceremony.

In my capacity as vice-president-elect of ASC, I attended the Australian/New Zealand Society of Criminology (ANZOC) Meetings in Sydney, Australia, October 1-3, 2003. The conference theme was "Controlling Crime: Risks and Responsibilities," and the meetings were held at the Australian Technology Park, which is a self-contained complex at the far side of the city. I brought along a box of ASC journals and brochures, and greeted attendees at an ASC table when I was not visiting sessions and meeting with people. Many persons were interested in ASC, our meetings, newsletter, and our journals. About 500 persons attended the meetings, and I was one of two Americans there that I was aware of. - **Individual Paper Presentation** – Requires only the submission of a title and abstract .
- **Poster Presentation** – Requires only the submission of a title and abstract. Posters should display data, policy analysis or theoretical work in a visually appealing poster format to encourage more interactive communication. All poster sessions will be held late Thursday afternoon, November 18<sup>th</sup>, 2004.
- **Completed Panel** – A completed panel consists of a minimum of three and a maximum of five papers. The on line form requires participants to submit all titles and abstracts for all papers and author information at the same time.
- **5-page Proposal Papers: Individual Submission** – Requires the submission of a paper that has demonstrated substantial preparation, although not completed, by the March 15<sup>th</sup> deadline. A five-page “preview” is required upon submission. Each proposal will be reviewed by one of the members of the Program Committee.
- **5-page Proposal Papers: Completed Panel** – Must follow the requirements in the Individual Submission above. Each proposal will be reviewed by one of the members of the Program Committee. The on line form requires the participants to submit all abstracts, titles, author information and 5-page preview at the same time.

## ASC IS USING ON-LINE SUBMISSION THIS YEAR!

This year, *all* abstracts for individual papers and for panels will be submitted on line through the ASC website.

This submission procedure differs from that used in previous years. In the past, presenters were instructed to send "program materials"—that is, information on the authors, title and abstract of the paper, 5-page proposal—to individual members of the Program Committee responsible for specific scholarly areas. For the 2004 meeting, however, we are using one central location to submit program materials. This means, of course, that you should **not** send your abstract/program materials directly to an area chair; he or she will not accept any such submissions.

### HOW TO SUBMIT PAPERS and PANELS

The following steps have been provided to guide you through the online submission process. If you have questions about submitting a paper and/or panel, please send an email to **ASCprogram.question@uc.edu**.

**Step 1:** Go to the ASC web page at **www.asc41.com/Nashville**

**Step 2:** Click to submit a paper and/or panel.

**Step 3:** Once you open this web page, you will first be asked to select what kind of submission you are making: 1) individual paper, 2) poster, 3) completed panel, 5-page proposal as either 4) an individual panel or 5) a completed panel.

You will then be asked to select the area and sub-area on the program to which you are submitting your program material. Both areas are listed on the following pages. Just "click" on the area and sub-area that you think best reflects the content of your paper.

To successfully submit your program material, you will need to complete information for your paper and for all authors on the paper. You also will be asked to supply an abstract of up to 300 words. So, before you begin, please have the following information available:

- Author and co-author information (e.g., complete mailing address, phone, email)
- Title and Abstract
- 5-page preview (if required)

**Step 4:** Once all information has been added, you will "click" on submit. You will receive an email notifying you that you have successfully submitted your paper and/or panel.

*Correctional Health Care Solutions Through Partnerships* will feature the **Hon. Vice Adm. Richard H. Carmona, M.D., M.P.H., F.A.C.S.**, surgeon general of the United States; and **Ed Thompson, M.D., M.P.H.**, deputy director for public health services, Centers for Disease Control and Prevention, to discuss issues relating to the role of public health in providing services to populations both within and leaving correctional settings. Also featured will be **Patricia L. Caruso**, director, Michigan Department of Corrections, to represent correctional administrators; the **Hon. Jacquelyn Barrett**, sheriff, Fulton County, Ga., representing local detention/jail administration; and **Dr. Fred Maue**, chief of clinical services, Pennsylvania Department of Corrections, representing correctional health services. **Richard L. Stalder**, secretary, Louisiana Department of Public Safety and Corrections, will serve as the program moderator. Additional presenters will be announced during the Webcast.

*Correctional Health Care Solutions Through Partnerships* is part of the series of health care and community workshops that will be presented at ACA's 2004 Winter Conference. These workshops, "Public Health Basics for Correction," "'Hot' Diseases in Corrections" and "Partnerships to Improve Community and Correctional Health," which will be open to conference attendees, will also be made available through ACA's Online Corrections Academy at [www.aca-oca.org](http://www.aca-oca.org) following the conference. ## Issue Background:

There are approximately 2 million people incarcerated in the United States and more than 6.6 million individuals are under some form of correctional supervision. Additionally, approximately 13 million people are admitted to the nation's jails annually, with about 631,000 people in U.S. jails at any one time. Numerous studies show that individuals who come in contact with the justice system are typically poor, uninsured, disproportionately members of minority groups, often homeless, and often have co-occurring substance abuse and mental disorders, placing them at increased risk for numerous chronic and contagious diseases. This population also suffers disproportionately from mental illness and alcohol/substance abuse.

In 1996 alone, 1.3 million inmates who were released from jail or prison were infected with hepatitis C, constituting 29 percent of the 4.5 million cases nationwide; released inmates accounted for 35 percent of the 34,000 Americans with tuberculosis that year; and newly released inmates accounted for 13 percent to 17 percent of Americans infected with HIV or AIDS. Rates of serious mental illness for these groups of people are about three to four times that of the general U.S. population, meaning that about 7 percent of all incarcerated people have a current serious mental illness; the proportion with any mental illness is substantially higher. These people are likely to continually recycle through the mental health, substance abuse and criminal justice systems giving rise to numerous problems that both corrections and public health must confront.

Many offenders have their first contact with the health care system while incarcerated. However, with growing pressure to reduce costs, correctional authorities are unable to provide preventative education and treatment to those entering the system. Furthermore, correctional agencies are often unable to establish effective partnerships with community health providers to ensure the continuity of care that is essential to combat disease transmission. *Correctional Health Care Solutions Through Partnerships* seeks to understand those issues that prevent collaborations between corrections and public health and explore methods for facilitating continuity of care to improve the health of our communities.
