ITEMS for discussion during the morning session:

- 1. Junior College as training centers for in-service training in communities where located. This presumes availability of competent instructors.
- 2. Junior College as pre-employment training center such as COS program.
- 3. Role of Supervisor of Peace Officer Training as that of coordination and assistance to Junior Colleges and to local police departments including operation of short-term programs for departments which cannot avail themselves of J.C. training.
- 4. State Colleges to assume role of advanced professional training over and beyond that which J.C's, are doing.
- 5. Universities to emphasize research, advanced training in broad field of law enforcement and preparation of teachers. Also must assume some responsibility for back-stopping teachers at the J.C. level by supplying teaching materials, putting on institutes and the like:
- 6. Specialized training could continue as at present through special institutes, conferences, seminars, meetings, and such programs as offered at Delinquency Control Institute (USC), Southern Police Institute (Louisewille), Northwestern, and F.B.I. Academy.

These items were presented as ideas for the group to discuss in addition to such others as may be brought up.

A word of explanation: The above 6 items are centered around the California system wherein numerous junior colleges have two-year criminology programs and several state colleges have four-year programs. Fresno has just be authorized to grant the MS in criminology. USC and California (Berkeley) have graduate programs. The State Department of Education, Bureau of Vocational Education, has a Supervisor of Peace Officers' Training who arranges for programs of training in local areas for police departments.
