MINUTES: Executive Committee, 30 March 1957

The Executive Committee of the S.A.C. met on 30 March 1957 in the President's Conference Room of the Administration Building, University of Southern California, Los Angeles, California.

The meeting was called to order at 10:00 a.m. by President Jack Kenney. The following were present: Jack Kenney, President; Clyde Vedder, Western Vice-President; Marcel Frym, Member-at-large; William Dienstein, Secretary-Treasurer; and Samuel Jameson, member.

It was agreed that the President notify again Professor Peter Lejins, University of Maryland, of his election as Eastern Vice-President at the 1956 Annual Meeting (Fresno) and if acknowledgement is not forthcoming to declare the office vacant.

The replacement of Professor A. C. Germann as Central Vice-President was also discussed.

Donal E. J. MacNamara was appointed as S.A.C. representative to the AAAS.

C. Robert Guthrie (Fresno State College) was named chairman of the Publications Committee and Editor of the Society. To serve on the Publications Committee with Guthrie were R. L. Soule (Southern Police Institute), Vernon Fox (Florida State University), and A. L. Berke (New Jersey).

Communication was read concerning the possibility of Florida State University publishing an S.A.C. Journal. The possibility was favored by the committee and the President will investigate further.

It was recommended that the Publications Committee strive for a goal of ten issues of an S.A.C. Newsletter each year; that the Editor urge members in the initial Newsletter to submit articles through him to the Journal of Criminal Law, Criminology, and Police Science and Police; that the Editor prepare for these two journals an S.A.C. News Section and that he correspond with the editors of these journals with this purpose in mind.

An expenditure of fifteen (15) dollars was authorized as the average cost of each issue of the Newsletter.

It was further requested of the S.A.C. Editor that institutions having criminology programs be circularized and requested that a statement of objectives of programs be submitted to the S.A.C. Editor. President Kenney will prepare a covering letter to accompany this request as well as include a copy of statement of objective for the program at USC.

Frank Boolsen (Fresno State College) was authorized to bring the S.A.C. Directory of Colleges and Universities offering Criminology Programs up-to-date and prepare sufficient copies thereof for distribution to members and others. Boolsen was requested to collect bulletins and information on all criminology programs and statements of objectives.

In the discussion of media for the dissemination of S.A.C. information and articles it was decided that the following publications be considered and communication with the editors be maintained:

Journal Criminal Law, Criminology, and Police Science,

American Journal of Corrections,

Journal of Correctional Education,

NPPA Journal,

Federal Probation, and

Journal of Social Therapy (Medical Correctional Association)

Marcel Frym will communicate personally with the editors of the NPPA Journal and the Journal of Social Therapy to pave the way for the S.A.C. editor. Vedder will communicate personally with the editors of the correctional journals for the same reason.

It was approved that Gourley (IA State College) continue his committee on standardization of titles for courses as well as content with the purpose of presenting a report at the 1957 Annual Meeting.

The meeting recessed at noon for luncheon and reconvened at 1:40 p.m. at which time the name of the Society and the revision of the constitution was discussed. Suggestions and comments received from the membership were discussed and acted upon.

It was decided that the membership at the time of voting on the new constitution should vote also on which of the following three names is preferred:
