**JOB TITLE: Lecturer/Assistant Teaching Professor in Criminal Justice (Justice Management)**

### JOB DESCRIPTION:

The Department of Criminal Justice in the College of Liberal Arts at the University of Nevada invites applications for a Full-Time Rank 0(II) Lecturer/Assistant Teaching Professor in the area of Justice Management in support of the Master of Justice Management degree program. The successful applicant will have duties in the areas of teaching (primarily online although there will be opportunities for teaching in-person), service, and professional development. Examples of courses include Introduction to Justice Management, Methods of Program Evaluation, Judicial Process, Applied Ethics, Research Methods, Court Management, and Juvenile and Family Law. Other courses may be possible based on the desires of the successful candidate and the approval of the department. Standard teaching load for a Lecturer is 4 courses per semester, but that can be adjusted through the assumption of additional administrative duties.

The successful candidate will have demonstrated excellence, or clear evidence of potential for excellence, in the teaching of Justice Management and related topics. Experience in the teaching of justice management and related topics. Five or more years of practical work experience in the criminal justice system. Evidence of attention to diversity, equity, inclusion, and access in teaching and laboratory operations.
